On behalf of The Breweries & Bottleyards Employees' Industrial Union of Workers of Western Australia, I respectfully request you to arrange, under Section 189 (1) of the Fair Work (Registered Organisations) Act 2009, an election for the following positions:

For a four year term commencing on 10th December 2010 and ending on 12th December 2014:

The reason for the election is that:

- a. The terms of office of the first 5 positions listed are due to expire in the normal course of events in accordance with the Unions Rules (Rules 10,13 & 14) and;
- b. The last position listed is a casual vacancy which is currently unfilled.

10.00 am Wednesday 17 November 2010	Close of ballot


If the above requested programme is used the Role for voters closed on 30 June 2010 (Rule 8) and;
the Role for candidates closed 6 months prior to the opening date for nominations (29 March 2010 - Rule 22 (4)).
