- 5. THAT, the number of persons who were members of The Civil Air Operations Officers' Association of Australia as of 31 December 2005, was the sum total of 1018 members.
- 6. THAT in accordance with the Civil Air Operations Officers' Association of Australia Rules [rule 34(e)], elections for Divisional Delegates shall be conducted each even numbered year for the following positions:
