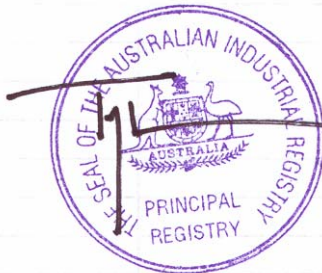
DECISION
