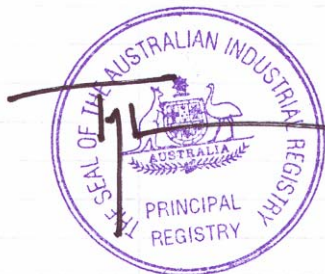
[1] On 3 September 2007 the abovenamed organisation lodged in the Industrial Registry the prescribed information in relation to an election for the following offices:
