- vii. As at 31 December 2011 the number of Members of the Federation was 2251 members (being 1456 contractor members and 705 Associate members).

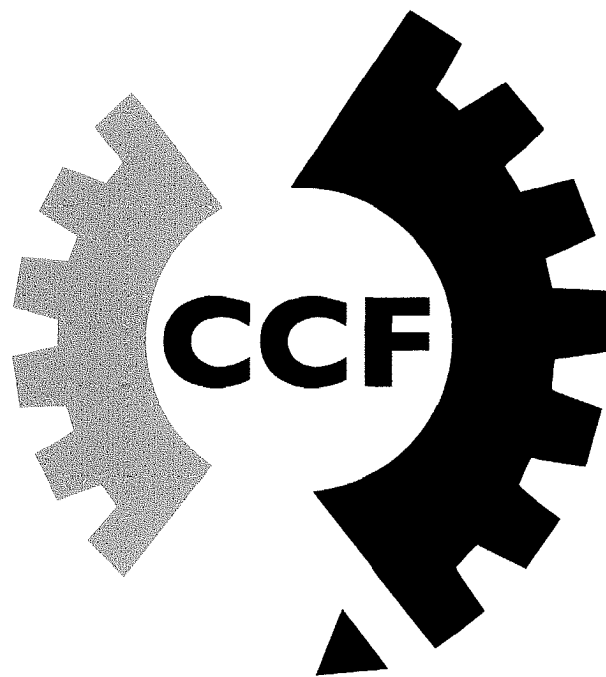
