IRREGULARITIES IDENTIFIED

Irregularity	Details
1. Contradictory rules:	Rule 46 relates to

Rule 46 relates to Branch Elections. Rule 46(e)(iii) stipulates that where there is a contest in the offices of Br Pres, Br Vice-President, Treasurer & Committee Member, *"the voting system will be a preferential voting system and will be carried according to Rule 28(c)(iv)"*. (Rule 28 relates to the election of National Councillors.) The contradiction lies in the following parts of Rule 28:

Rule 28 (c)(iv)(i) stipulates that "a voter shall record his vote on a ballot paper as follows. He shall place the figures 1,2,3,4, and so on against the names of <u>each and every candidate</u> so as to indicate by such numerical sequence the order of his preference. A consecutive number must be placed in each square commencing with the number '1' otherwise the ballot paper will be rejected as informal."

HOWEVER

Rule 28 (c) (viii)(b) stipulates that "Any vote in respect of the election of a person to an office shall be informal if:- A voter votes for a greater or lesser number of candidates than the number of offices to be filled"

One rule requires the complete numbering of every square but the second rule implies that a voter must only number the exact number of squares/offices to be filled, for the vote to be formal. 2. Unworkable rule: Rule 28 (c)(iv)(iii) relates to the process of excluding candidates:- "If no candidate has received an absolute majority of first preference votes, The candidate who receives the fewest first preference votes shall be excluded and each voting paper counted to him shall be counted to the candidate next in order of the voters preference provided that where the least number of first preference votes is received by two or more candidates <u>a second ballot</u> <u>conducted in a similar manner to the first ballot</u> shall be held to determine which of these candidates shall be first eliminated from the original ballot for that position."

The above underlined part of the rule is unworkable. In practice, it is not possible to hold a second postal ballot in the middle of a current postal ballot.

It is quite likely that the above underlined part of the rule was written for the context of a situation where members are in attendance at a meeting (where an attendance ballot is being held), and is therefore not suitable to be applied in a postal ballot situation.

ACTION TAKEN IN RELATION TO IRREGULARITIES

Nil. Fortunately, no ballots were required on this occasion.



Re: Conduct of elections

I refer to your letter of 9 July 2003 requesting that arrangements be made for the conduct of an election for certain offices within the Australian Capital Territory Branch of the Civil Contractors Federation.

I note the office of Branch Executive Director has not been included in the above notification. Our records indicate that no notification has ever been made for the conduct of an election for such office. This matter has been discussed recently between Mr. Powell of this office and a member of your staff who advised that at the present time the branch does not intend to lodge a notification in respect of the office of Branch Executive Director.

Subsection 182(1) of Schedule 1B of the Workplace Relations Act 1996 requires each election for an office in an organisation, or branch of an organisation, to be conducted by the Australian Electoral Commission unless an exemption is granted under s186 of Schedule 1B. No exemption currently exists in relation to the office of Branch Executive Director.

Subsections 189(1) and (2) of Schedule 1B require an organisation or branch of an organisation to lodge in the Industrial Registry the prescribed information in relation to an election that is to be conducted by the Australian Electoral Commission before the prescribed day or such later day as a Registrar allows - refer regulation 138 of the Workplace Relations (Registration and Accountability of Organisations) Regulations 2003. Subregulation 138(2) requires that such information contain a statement, signed by an officer of the organisation or branch who is authorised to sign the statement, that the information is lodged under subsection 189(1) of the RAO Schedule.

Rule 46A(a) of the rules of the organisation provides:

"(a) There shall be a Secretary of each Branch who shall be known as the Branch Executive Director who shall be the principal salaried officer of the Branch and shall hold office for three years. He shall be elected by the members of the branch and his remuneration and conditions of employment shall be determined by the branch committee of management. His election will take the form of a secret postal ballot and shall make provision for absent voting."

Having regard to the above, I have some doubt as to whether you are able to continue to hold such office. Therefore, I am not satisfied at this time that you are an officer of the branch as referred to in regulation 138 capable of lodging a notification pursuant to subsections 189(1) and (2).

In order for me to make arrangements for the offices requested, you would either need to provide me with a submission as to how you remain an officer of the branch or alternatively (so as to arrange for the conduct of the election in accordance with the timetable set out in your letter), arrange for an officer of the branch i.e. the President or Vice-President to lodge a notification for the positions previously requested.
