Rules difficult to apply:

1. Unworkable rules:

Rule 29 (f) (iii) C(1) relates to the process of excluding candidates and procedure in relation to a situation of tied number of votes:- "If no candidate has received an absolute majority of first preference votes, The candidate who receives the fewest first preference votes shall be counted to the candidate next in order of the voters preference provided that where the least number of first preference votes is received by two or more candidates a second ballot conducted in a similar manner to the first ballot shall be held to determine which of these candidates shall be first eliminated from the original ballot for that position."

The above underlined part of the rule is unworkable. In practice, it is not possible to hold a second postal ballot in the middle of a current postal ballot

It is quite likely that the above underlined part of the rule was written for the context of a situation where members are in attendance at a meeting (where an attendance ballot is being held), and is therefore not suitable to be applied in a postal ballot situation.

Rule 50 (e) (iii) C (1) also relates to the process of excluding candidates and procedure in relation to a situation of tied number of votes:- "If no candidate has received an absolute majority of first preference votes, The candidate who receives the fewest first preference votes shall be excluded and each voting paper counted to them shall be counted to the candidate next in order of the voters preference provided that where the least number of first preference votes is received by two or more candidates a second count conducted in a similar manner to the first count shall be held to determine which of these candidates shall be first eliminated from the original ballot for that position."

Again, this is a similar situation to that mentioned above, as per Rule 29 (f) (iii) C(1).

[Note: To remedy that part of the unworkable rule, remove the underlined part of the rules and instead stipulate that, "the Returning Officer shall conduct a draw by lot" to determine which of the tied candidates is to be eliminated.]

Re: Post Election Report - Civil Contractors Federation - ACT Branch

In reference to your post-election report of 17 August 2007, identifying Rules 29 (f) (iii) C(1) and Rule 50 (e) (iii) C(1) as "unworkable rules", the ACT Branch of the Federation have requested that National Office advise you of the organisation's intended action.

These rules were identified as "Rules difficult to apply/interpret" in the 2006 CCF South Australian Branch post election report. The CCF National Rules Committee has since reviewed the rules in relation to other issues and has recommended alterations to remedy the unworkable parts of the rules. Specifically the two Rules identified above are recommended for change.

At a meeting held on 10 August 2007, the National Board accepted the Rules Committee's recommendations and in accordance with the Federation's Rules, instructed the CEO (National) to convene a Special General Meeting of Members on October 25 to put forward and vote on the proposed alterations.

The above underlined part of the rule is unworkable. In practice, it is not possible to hold a second postal ballot in the middle of a current postal ballot.

It is quite likely that the above underlined part of the rule was written for the context of a situation where members are in attendance at a meeting (where an attendance ballot is being held), and is therefore not suitable to be applied in a postal ballot situation.

Rule 50 (e) (iii) C (1) also relates to the process of excluding candidates and procedure in relation to a situation of tied number of votes:- "If no candidate has received an absolute majority of first preference votes, The candidate who receives the fewest first preference votes shall be excluded and each voting paper counted to them shall be counted to the candidate next in order of the voters preference provided that where the least number of first preference votes is received by two or more candidates a second count conducted in a similar manner to the first count shall be held to determine which of these candidates shall be first eliminated from the original ballot for that position."

Again, this is a similar situation to that mentioned above, as per Rule 29 (f) (iii) C(1).

[Note: To remedy that part of the unworkable rule, remove the underlined part of the rules and instead stipulate that, "the Returning Officer shall conduct a draw by lot" to determine which of the tied candidates is to be eliminated.]

RE: LODGEMENT OF PRESCRIBED INFORMATION IN RELATION TO AN ELECTION FOR OFFICE IN AN ORGANISATION

Pursuant to Section 189 of Schedule 1 of the Workplace Relations Act 1996, I hereby lodge in the Industrial Registry, the "prescribed information" specified in Regulation 138 of the Workplace Relations (Registration and Accountability of Organisations) Regulations in relation to the Civil Contractors Federation ACT Branch election to be conducted by the AEC:

(c) if more than one of the offices or positions for which an election is required has the same name, and the number of offices or positions can, under the rules of the relevant organisation or branch, be determined before the prescribed day - the number of those offices or positions;

- (i) Branch Board Member (4)
- (d) if the electorate comprises only members of a branch, section or other division of an organisation the name of the branch, section or division;

Members of the Civil Contractors Federation ACT Branch.

- (e) the date and time of the beginning and end of the period in which nominations of candidates will be called for or may be made under the rules of the organisation or branch in relation to the election;
 - (i) Nominations shall be called for not less than fifty days in advance of the date fixed for the Annual General Meeting [see Rule 29(b) and Rule 50(a)(i)]
 - NB. The date fixed for the Annual General Meeting of the Branch is Tuesday 2 October 2007 therefore nominations must be called prior to 9 August 2007.
 - (ii) The closing date for nominations shall be not less than thirty days before the date of the Annual General Meeting. [see Rule 29(c) and Rule 50(a)(i)]

NB. The proposed date for the Branch Annual General Meeting is 2 October 2007, therefore the closing date for nominations is 14 August 2007.

(f) the day provided for in the rules of the organisation as the day on which the roll of voters is to be closed;

The roll of voters for any ballot shall close 7 days before the day on which nominations for the election open [see Rule 28].

NB. As the date fixed for the Annual General Meeting of the Branch is 2 October 2006 and nominations open on 31 July 2007, the roll of voters is to be closed on 24 July 2007.

(g) the kind of voting system to be used in the conduct of the election is:

A direct voting system [see Rule 29(f)(iii) and Rule 50(e)(iii)]
