- (e) the date and time of the beginning and end of the period in which nominations of candidates will be called for or may be made under the rules of the organisation or branch in relation to the election;
  - (i) Not less than 50 days in advance of the date fixed for the Annual General Meeting, the Branch Returning Officer shall by post invite nominations from members included in the Branch for election to the offices of Branch President, Branch Vice President, Honorary Treasurer and Committeeman [Rule 46(a)(i)].
    - NB. The date fixed for the Annual General Meeting of the Branch is the 29 September, 2005 therefore, nominations must be called prior to the 10 August, 2005.
  - (ii) The closing date and hour for the receipt of nominations shall be not less than 30 days before the date of the Annual General Meeting [Rule 46(a)(i)].
    - NB. The date fixed for the Annual General Meeting of the Branch is the 29 September, 2005 therefore, the closing date for nominations is the 30 August, 2005.
- (f) the day provided for in the rules of the organisation as the day on which the roll of voters is to be closed;

The role of voters for any ballot shall close 7 days before the day on which nominations for the election open [Rule 27A].

NB. As the date fixed for the Annual General Meeting of the Branch is the <u>29 September</u>, <u>2005</u> and nominations close on the <u>10 August</u>, <u>2005</u>, the rolls are to be closed on the <u>3 August</u>, <u>2005</u>.

Accordingly, we hereby lodge in the Industrial Registry, the "prescribed information" specified in Regulation 138 of the Workplace Relations (Registration and Accountability of Organisations) Regulations in relation to the pending election:

### Prescribed information:

- (a) the name of each office or position for which an election is required;
  - (i) President (1) [Rule 41];

- (b) the reason for the election is that:

The term of the office or position has expired [or will expire] in the normal course of events.

- (c) if more than one of the offices or positions for which an election is required has the same name, and the number of offices or positions can, under the rules of the relevant organisation or branch, be determined before the prescribed day the number of those offices or positions;
  - (i) Committee Members (7) [Rule 46(c)]; and
  - (ii) Councillors (2) [Rule 28(b)].
- (d) if the electorate comprises only members of a branch, section or other division of an organisation the name of the branch, section or division;

The electorate comprises only members of the Civil Contractors Federation – Northern Territory Branch.

- 25(a) Each Branch shall elect from its members (2) Councillors who collectively comprise Council
- (b)(i) Council of Fed consists of N. Pres., N.V. Pres., an Hon Treas. and such other member of Ord Councillors as is sufficient to allow each Branch a total of 2 members of Council all of whom shall be elected.
- 28(a) Not less than 50 days in advance of the date fixed of the AGM the RO shall by pre-paid post invite noms from fin members of the branch for election of 2 Councillors at the same time advising each fin member of the closing date and hour for receipt of nom which shall not be less that 30 days before the date of the AGM.
- (c)(ii) RO shall determine opening and closing dates of noms and ballots
- (iii) RO shall not less than 21 days prior to the date of the holding of the AGM deliver to each fin member by pre-paid post a ballot paper.
- (vi) RO shall advise all voters of the closing date and hour for the receipt of returned ballot papers which he shall fix and which shall be not less than 3 days but nor more than 10 days before AGM
- (xi) Result of ballot declared during AGM
- (xii) Each person elected to position shall take up office immediately.
- (41) Each Branch shall be a President, V-President, Treasurer and such number of Committee Members as the committee may from time to time determine not being less than 3 nor more than 11 whom shall be elected.
- 40(b) There shall be provision for the development of a Branch in each State or Territory of Australia.
  - The Branches shall be known as NSW, Victoria, Qld, SA, WA and Tas. The development of the ACT and NT Branch shall occur should the Nat Council motion development of such branches
- 45A(a) AGM for Branch shall be held during the month of August and September within 13 months of the previous BAGM.
- 46(a)(i) Not less than 50 days in advance of the date fixed for the AGM the Branch RO shall by post invite noms from members included in the Branch for election to the offices of Br Pres, Br V Pres, Br Hon Treas, and Committeemen, at the same time advising each such member of the closing date and hour for receipt of noms which shall be not less than 30 days before the date of the AGM.

- (e)(ii) Br RO shall not less than 21 days prior to the date of the holding of the AGM of the Br deliver to every fin member entitled to vote in the election of Branch Office bearers by prepaid post a ballot paper.
- (iv) Br RO shall advise all voters of the closing date and hour for the receipt of returned ballot papers which he shall fix and which shall not be less than 5 days but not more than 10 before the date of AGM
- (xii) Result of ballot shall be declared during AGM
- (g) Member of Committee of a Branch shall hold office until the conclusion of the next AGM of the Branch
- (i) Each person elected within Fed shall take up position immediately.

  Declared by RO during AGM
- 46A(a)Sec of each Branch shall be known as the Branch Exec Director and shall hold office for 3 years. He shall be elected by the members of the Branch. His election will take in the form of a secret postal ballot.
- (b) 1st election of a Br Exec Director under these rules and subsequent elections shall be conducted by the Br RO and noms for the office shall be sought from members of the branch committee of management, any member of which may nominate any person for the office. Rule 28 shall apply mutatis mutandis
