## RE: LODGEMENT OF PRESCRIBED INFORMATION IN RELATION TO AN ELECTION FOR OFFICE IN AN ORGANISATION

**(b) *the reason for the election is that:***

The terms of office are due to expire in the normal course of events under the rules of the organisation.

**(c) *if more than one of the offices or positions for which an election is required has the same name, and the number of offices or positions can, under the rules of the relevant organisation or branch, be determined before the prescribed day - the number of those offices or positions;***

(i) Branch Board Member (11)

[see Rule 43]

**(d) *if the electorate comprises only members of a branch, section or other division of an organisation - the name of the branch, section or division;***

Members of the Civil Contractors Federation, Northern Territory Branch.

**(e) *the date and time of the beginning and end of the period in which nominations of candidates will be called for or may be made under the rules of the organisation or branch in relation to the election;***

(i) Nominations shall be called for not less than fifty days in advance of the date fixed for the Annual General Meeting [see Rule 29(b) and Rule 50(a)(i)]

NB. The date fixed for the Annual General Meeting of the Branch is 21 September 2006, therefore nominations must be called prior to 1 August 2006. A date of 28 July 2006 has been set for call of nominations.

(ii) The closing date for nominations shall be not less than thirty days before the date of the Annual General Meeting. [see Rule 29(c) and Rule 50(a)(i)]

NB. The proposed date for the Branch Annual General Meeting is 21 September 2006, therefore the closing date for nominations is 21 August 2006. A date of 18 August 2006 has been set for closing nominations.

**(f) *the day provided for in the rules of the organisation as the day on which the roll of voters is to be closed;***

The roll of voters for any ballot shall close 7 days before the day on which nominations for the election open [see Rule 28].


NB. As the date fixed for the Annual General Meeting of the Branch is 21 September and nominations open on 28 July 2006, the roll of voters is to be closed on 21 July 2006.

**(g) *the kind of voting system to be used in the conduct of the election is:***

A direct voting system [see Rule 29(f)(iii) and Rule 50(e)(iii)]
