*NB. The date fixed for the Annual General Meeting of the Branch is 18 September 2008 therefore nominations must be called prior to 30 July 2008 and will be called on 21 July 2008.*

- (ii) The closing date for nominations shall be not less than thirty days before the date of the Annual General Meeting. [see Rule 29(c) and Rule 50(a)(i)]

*NB. The proposed date for the Branch Annual General Meeting is 18 September 2008, therefore the closing date for nominations is 19 August 2008 and will close on 11 August 2008.*

- (f) *the day provided for in the rules of the organisation as the day on which the roll of voters is to be closed;*

The roll of voters for any ballot shall close 7 days before the day on which nominations for the election open [see Rule 28].

*NB. As the date fixed for the Annual General Meeting of the Branch is 18 September 2008 and nominations open on 21 July, the roll of voters is to be closed on 14 July 2008.*
