

Rule 45A(a)

"The Annual General Meeting of the members of each Branch of the Federation shall be held during the month of August or September within 13 months of the previous Branch Annual General Meeting at such times and places as may be determined by the Branch Committee of Management."

The last Branch Annual General Meeting was held on 11 September 2003.

- The proposed date for the 2004 Branch Annual General Meeting is 16 September 2004.
- The voting system to be employed in the conduct of the election being a direct voting system.
