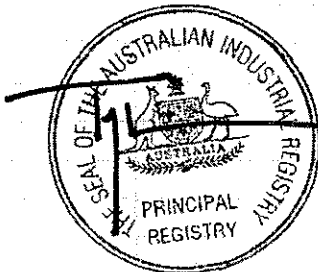

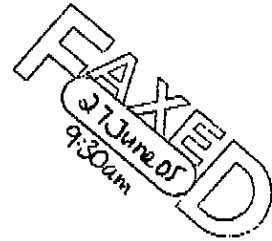

Application is hereby made pursuant to Section 214 and Regulation 61 of the Workplace Relations Act 1996, to have an election conducted by the Australian Electoral Commission for the election of officers of the Queensland Branch of the Civil Contractors Federation.

◆ The name of each office, for which an election is required, is as follows:

- Branch President
- Branch Vice President
- Branch Treasurer
- Branch Committee Members (Maximum 11, Minimum 3)
- National Councillors (2)
- Branch Executive Director

◆ The reason for the election being that the term of office will expire on 22 September 2005.

◆ The Rules provide:

**Rule 28A(d)** "If only the required number of nominations to fill any office or offices is received, the Returning Officer shall by notice addressed to the Queensland Executive Director forthwith declare the person or persons so nominated unopposed."

**Rule 28A(e)** "If more than the number of nominations required to fill any office received an election shall be taken by secret ballot of all members of the Branch as hereinafter provided."

- ♦ The date and time of the commencement and expiration of the period during which nominations of candidates will be called for or may be made under the rules of the Branch in respect of the election:

**Rule 45A(a)** "The Annual General Meeting of the members of each Branch of the Federation shall be held during the month of August or September within 13 months of the previous Branch Annual General Meeting at such times and places as may be determined by the Branch Committee of Management."

The last Branch Annual General Meeting was held on 16 September 2004.

- ♦ The proposed date for the 2005 Branch Annual General Meeting is 22 September 2005.
- ♦ The voting system to be employed in the conduct of the election being a direct voting system.
