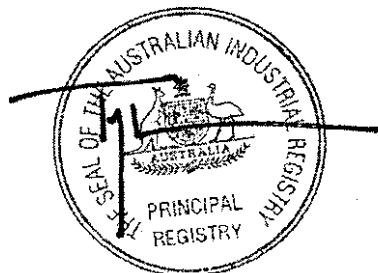

The last AGM of the SA Branch was held on the 13th August 2003.


