Re: Post Election Report – Civil Contractors Federation – SA Branch (E No 2007/172)

We have noted your post-election report of 11 October 2007, identifying Rules 29 (f) (iii) C(1) and Rule 50 (e) (iii) C(1) as "Rules difficult to apply/interpret", and wish to advise you of the organisation's intended action.

These rules were identified as "Rules difficult to apply/interpret" in the 2006 CCF South Australian Branch post election report. The CCF National Rules Committee has since reviewed the rules in relation to other issues and has recommended alterations to remedy the unworkable parts of the rules. Specifically the two Rules identified above were recommended for change.

At a meeting held on 10 August 2007, the National Board accepted the Rules Committee's recommendations and in accordance with the Federation's Rules, instructed the CEO (National) to convene a Special General Meeting of Members on October 25 to put forward and vote on the proposed alterations.

At the Special General Meeting of Members held on 25 October 2007 a resolution approving the proposed alterations was carried unanimously. The Federation will be seeking certification by the Industrial Registrar as soon as practicable.

Pursuant to Section 189 of Schedule 1 of the Workplace Relations Act 1996, I hereby lodge in the Industrial Registry, the "prescribed information" specified in Regulation 138 of the Workplace Relations (Registration and Accountability of Organisations) Regulations in relation to the Civil Contractors Federation South Australian Branch election to be conducted by the AEC:

The terms of office are due to expire in the normal course of events under the rules of the organisation.

- (c) if more than one of the offices or positions for which an election is required has the same name, and the number of offices or positions can, under the rules of the relevant organisation or branch, be determined before the prescribed day the number of those offices or positions;
 - (i) Branch Board Member (11) [see Rule 43]

(d) if the electorate comprises only members of a branch, section or other division of an organisation - the name of the branch, section or division;

Members of the Civil Contractors Federation South Australian Branch.

- (e) the date and time of the beginning and end of the period in which nominations of candidates will be called for or may be made under the rules of the organisation or branch in relation to the election;
 - (i) Nominations shall be called for not less than fifty days in advance of the date fixed for the Annual General Meeting [see Rule 29(b) and Rule 50(a)(i)]
 - NB. The date fixed for the Annual General Meeting of the Branch is 29th August 2007, therefore nominations must be called prior to 10 July 2007.
 - (ii) The closing date for nominations shall be not less than thirty days before the date of the Annual General Meeting. [see Rule 29(c) and Rule 50(a)(i)]
 - NB. The proposed date for the Branch Annual General Meeting is 29th August 2007, therefore the closing date for nominations is 30 July 2007.
- (f) the day provided for in the rules of the organisation as the day on which the roll of voters is to be closed;

The roll of voters for any ballot shall close 7 days before the day on which nominations for the election open [see Rule 28].

NB. As the date fixed for the Annual General Meeting of the Branch is 29th August 2007 and nominations open on 9th July 2007, the roll of voters is to be closed on 2nd July 2007.

(g) the kind of voting system to be used in the conduct of the election is:
