(d) if the electorate comprises only members of a branch, section or other division of an organisation - the name of the branch, section or division;

- (e) the date and time of the beginning and end of the period in which nominations of candidates will be called for or may be made under the rules of the organisation or branch in relation to the election;
 - (i) Nominations shall be called for not less than fifty days in advance of the date fixed for the Annual General Meeting [see Rule 29(b) and Rule 50(a)(i)]
 - NB. The date fixed for the Annual General Meeting of the Branch is 14/9/2010 therefore nominations must be called prior to 23/7/2010.
 - (ii) The closing date for nominations shall be not less than thirty days before the date of the Annual General Meeting. [see Rule 29(c) and Rule 50(a)(i)]

NB. The proposed date for the Branch Annual General Meeting is 14/9/10 therefore the closing date for nominations is 13/8/10.

(f) the day provided for in the rules of the organisation as the day on which the roll of voters is to be closed;

The roll of voters for any ballot shall close 7 days before the day on which nominations for the election open [see Rule 28].

NB. As the date fixed for the Annual General Meeting of the Branch is 14/9/2010 and nominations open on 23/7/2010, the roll of voters is to be closed on 16/7/2010.

(g) the kind of voting system to be used in the conduct of the election is:
