Re: Schedule 1B of the Workplace Relations Act 1996 (the RAO Schedule) Financial reports for year ended 30 June 2005 - FR 2005/334

Reference is made to the financial reports of the Western Australian Branch of the Civil Contractors Federation for the year ended 30 June 2005. The documents were lodged in the Industrial Registry on 8 September 2005.

The documents have been filed.

Although the documents have been filed, I would like to comment on some issues arising out of the reports. I make these comments to assist you when you next prepare financial reports. You do not need to take any further action in respect of the financial reports already lodged.

1. Operating Report

(a) Membership of Committee of Management:

The operating report is required to contain the name of each person who has been a member of the committee of management of the reporting unit at any time during the reporting period, and the period for which he or she held such a position - refer regulation 159(c) of the RAO Regulations.

The operating report should have provided the positions which <u>all</u> members of the committee of management held during the reporting unit.

(b) Right of members to resign

Subsection 254(2)(c) requires the operating report to "give details" of the right of members to resign from the reporting unit under section 174 of the RAO Schedule. The requirement may be met by the inclusion of a statement that a member has the right to resign and a reference to the relevant rule, which makes such provision. Alternatively, the complete text of the relevant resignation rule may be reproduced in the report. It would appear in this case that rule 9 of the organisation's Rules is applicable.

3. Committee of Management's Statement

There appears to be no information in the statement addressing Items 17(e)(iv) and (vi) of the Industrial Registrar's Reporting Guidelines. These items relate to the keeping of financial records in a consistent manner to each of the other reporting units of the organisation and whether there has been compliance with any order for inspection of financial records made by the Commission.

Also, I note that paragraph 7 of the Committee of Management Statement provides the statement in relation to the provision of records to members which was required by the previous financial reporting requirements. Item 17(e)(v) of the Reporting Guidelines requires a declaration as to whether any information sought in any request of a member or Registrar made under section 272 has been furnished to the member or Registrar

It should be noted that the Committee of Management Statement must address all the requirements stipulated in the Industrial Registrar's Guidelines.

4. Notice to members

I note that the notice to members provides the provisions of section 274 of the Workplace Relations Act 1996. The accounts should set out the provisions of subsections 272(1), (2) and (3) of the RAO Schedule. Would you please ensure those subsections are copied into the GPFR in the next financial report of the Branch.

It should be noted that the Industrial Registrar attaches importance to reporting units both fully satisfying the obligations under Schedule 1B and to those obligations being discharged within the requisite timeframes. Your reporting unit should therefore ensure that future financial returns fully satisfy the above obligations.

Note 1: Statement of Significant Accounting Policies

The financial report is a general purpose financial report that has been prepared in accordance with Australian Accounting Standards, Urgent Issues Group Consensus Views and other authoritative pronouncements of the Australian Accounting Standards Board. This report has been prepared as appropriate to meet the needs of the members, the Federation's constitution and the relevant legislative requirements of the Workplace Relations Act 1996, as amended and the Workplace Relations Regulations 1996.

The financial report has been prepared on an accruals basis and is based on historical costs and does not take into account changing money values or, except where stated, current valuations of non-current assets. Cost is based on the fair values of the consideration given in exchange for assets.

The following is a summary of the material accounting policies adopted in the preparation of the financial report. The accounting policies have been consistently applied, unless otherwise stated.

Historical Cost

The accounts have been prepared on the basis of historical costs and do not take into account changing money values, or except where stated, current valuations of non-current assets.

Accruals Basis

The Fedration has determined that in accordance with subsection 272 (2) of the Workplace Relations Act 1996, as amended it will prepare the accounts on an accrual basis.

Income Tax

The Federation is exempt from Income Tax under Section 50-15 of the Income Tax Assessment Act 1997, as amended, accordingly the Federation does not account for income tax.

Investments

Investments are bought to account at cost or at valuation. The carrying amount of investments is reviewed annually to ensure that it is not in excess of the recoverable amount of the investments. Dividends and interest are bought to account in the Income and Expenditure statement when received.

Property, Plant and Equipment

Property, plant and equipment are included at cost or where stated at independent valuation. All fixed assets, not subject to independent valuation, including buildings but excluding freehold land, are depreciated using rates and methods estimated to write off the cost over the estimated useful life of the asset concerned and commencing from the time the asset is held ready for use.

Leases

Leases of fixed assets, whether for finance leases or operating leases, are charged as expenses in the periods which they are incurred.

Contributions are made by Civil Contractors Federation Western Australia Branch to an employee superannuation fund and are charged as expenses when incurred.

Employee Entitlements

Provision is made for the Federation's liability for annual leave and long service leave arising from services rendered by employees to the reporting date. The provision for long service leave includes the Federation's legal obligation and expected future payments where no legal entitlement has arisen and the employee has completed at least seven years of service.

Liabilities have not been discounted to their present values.

Contributions are made to an employee superannuation fund are charged as an expense when incurred. Other than as required by the Superannuation Guarantee Legislation, there is no legal obligation to provide benefits to employees on retirement.

NOTICE TO MEMBERS

Information to be provided to Members or Registar

In accordance with subsection 272(2) of the RAO schedule, as amended, the attention of the members is drawn to subsections 272 (1), (2), (3) and reference to subsection 275 (5) of the RAO schedule which provides as follows:

- (1) A member of an organisation, or a Registrar, may apply to the organisation for specified prescribed information in relation to the organisation.
- (2) An organisation, shall, on application made under subsection (1) by a member of the organisation or a Registrar, make the specified information available to the members or Registrar in such manner, and within such time, as is prescribed.
- (3) A Registrar may only make an application under subsection (1) at the request of a member of the organisation concerned, and the Registrar shall provide to the member information received because of an application made at the request of the member.

 - The Trenchless Technology Training Package project received further funding in June 2005 to continue with the development of a Trenchless Technology training package for the industry.
 - The Occupational Safety & Health Induction Course project has concluded and funding assisted with the redesign and rewrite of the OSH Induction Course and manual. The course is now regularly conducted by CCF trainers for members and others. WorkSafe WA is utilising the CCF program as a base for the creation of an industry standard course for mandatory use prior to commencing work in the civil construction industry, just as MARCSTA is mandatory for the mining industry.
 - The Supervisory/Frontline Management Training Package project funding assisted with the contextualisation and development for the integration of supervisory and frontline management skills into the civil construction stream at Certificate IV level.
