Time Frame for Conduct of Elections

Constitution

- 16 (a) The election date shall be nominated by the Council and shall be not more than 3 months nor less than one month prior to the AGM.
- 16 (c) The Returning Officer shall give notice of a forthcoming election and call for nominations for candidates at least 28 days before the date fixed by him for the closing of nominations. Such closing date shall be not less than one month prior to the Election date.
- 16 (d) The Returning Officer shall call for nominations for the balance of positions available, the closing date for nominations shall be not less than 21 days prior to the Election date.
- 16 (f) If the Returning Officer finds any nomination to be defective, he shall give the person concerned the opportunity of remedying the defect within a period of not less than 7 days of receipt of his notice.
- 16 (g)(i) Notice that an Election will be held shall be given at least 14 days before the closing date for voting. The closing time and date for voting shall be not later than 24 hours before the Election date.
- 16 (g) (ii) The Returning Officer shall issue the necessary ballot papers to each member eligible to vote not less than 7 days before the closing date of voting.
- 16 (g) (vii) The Returning Officer will declare the result of the Election on the Election date. Candidates elected shall assume office 3 days following the Election date.
- 16 (j) (ii) Within 14 days of declaration of the ballot, the Returning Officer shall submit to the Council a written report on such elections.
- 20 The AGM shall be held within 15 months of the last AGM (23 August 2005) on a date to be fixed annually by the Council.
- 20 Notice of the AGM shall be given at least 14 days previously to all members.
- 21 (b) Members shall give the Executive Director notice of the names of representatives and delegates, not less than 48 hours before the AGM. Quorum = 25 voting members
