Annual Return of Information [AR2013/183 and AR2014/113]

I acknowledge receipt on 1 February 2013 of your Declaration in matter AR2013/183 providing information in accordance with subsection 233(1) of the *Fair Work (Registered Organisations) Act 2009* (the Act). Further information was received on 27 September and 28 October 2013. The documents lodged cover the required information for the 2013 Annual Return of Information of Clubs Victoria Inc.

I also acknowledge receipt on 31 January 2014 of your Declaration in matter AR2014/113 in accordance with the Act. The documents lodged cover the required information for the 2014 Annual Return of Information of Clubs Victoria Inc.

I have filed the Annual Returns of Information for 2013 and 2014 but am providing additional information to clarify the repeated problem with these returns and to emphasise the need to remedy the problem in future returns.

Section 230(1)(b) of the Act requires a list of all Offices of the organisation and s.230(1)(c) requires a list of the names, postal addresses and occupations of the holders of those Offices.

Rule 14.2 of your rulebook states “The Council shall comprise fifteen (15) Councillors...”. This is a definite number - not a range of “between x and y” or “up to”. In addition, the Councillors are elected by region of business.

Rule 15.1 then lists the Executive who are elected from the Councillors - President, Metropolitan Vice President, Country Vice President and Treasurer. [Note: the Executive Director is not an Office holder under the Act.]

The 15 Councillors including the Executive offices make up the complete list of Offices of the organisation. The attachment ‘List of Officers’ that you have supplied only has 11 names and therefore only cites 11 of the 15 Councillor Offices.

The list of holders of Office should then have either a name or ‘Vacant’ associated with each of the 15 directly elected Offices. Your attachment ‘List of Officers’ does indicate the Metro and Regional Vice Presidents but should also define which Councillors are Metro and which are Regional. I note that you refer to ‘Regional’ but the Rules refer to ‘Country’ and the Annual Return should reflect the Rules.

In closing, I draw to your attention: The list of Office holders lodged last year stated that Mark Griffith's term was to expire in 2013; the list this year states that his term expires 2014. These two statements disagree.

No action is required in respect of these Annual Returns of Information but please ensure that the return lodged in 2015 is complete.


