I acknowledge receipt by the Registered Organisations Commission (the ROC) on 9 January 2019 of your organisation's Annual Return which provides information under subsection 233(1) of the *Fair Work (Registered Organisations) Act 2009* (the RO Act).

Thank you for providing your Annual Return.

The ROC aims to help organisations comply with all the requirements of subsection 233(1) of the RO Act. Accordingly the ROC requested that another declaration be provided, and this was provided by your organisation on 24 April 2019 regarding:
