- (8) a record of the number of members of the organisation as at 31 December 2006.
- (9) a record of the number of any members who were ineligible State members within the meaning of s.150 (only if the organisation has entered into a s.151(1) agreement).

(10) a *declaration* signed by you or other prescribed officer that the preceding copies of information being lodged are correct statements of the information contained in the organisation's records

Regulation 149 of the Workplace Relations (Registration and Accountability of Organisations) Regulations 2003 required this information to have been lodged by **31 March 2007**.

You should note that failure to comply with this obligation is subject to a civil penalty provision under section 305 of the RAO Schedule.
