**CEPU Annual Return for reporting periods 31 Dec 2010-31 Dec 2016**

I refer to the above and to our previous correspondence. I enclose by way of lodging:

- declaration amending the CEPU's annual returns.


The enclosed declaration is modelled on the template return published by the Registered Organisations Commission (ROC) and amends the membership figures to reflect the results of the audit process detailed below. I advise that a copy of this amending declaration will be posted to the CEPU's website.

As you are aware, in response to the Fair Work Commission (FWC) questioning the validity of the reporting of CEPU membership figures,<sup>1</sup> the CEPU instigated an independent audit of the membership figures reported in our annual returns and committee of management operating reports for the years ended 31 December 2013-31 December 2015 and 31 March 2013-2015 respectively. On 11 November 2016, the CEPU provided the FWC with the report of the independent audit, which included a table showing the variance between the reported membership figures and the audited number of total members for those reporting periods.

On 16 March 2017 the FWC wrote to the CEPU expressing dissatisfaction with the timeframe of the first audit only covering the three years of reporting periods. On 13 April 2017 the CEPU responded to the concerns expressed by the FWC and advised we would be conducting a second audit adopting the FWC terms of reference in the 16 March correspondence (Annexure E), excluding redoing the audit for 31 December 2013 to 31 December 2015. We further advised the FWC that each Division would be engaging their own auditor to conduct the second round of audits.

As a consequence of the second round of independent audits, on 11 December 2017, the CEPU National Council, at its annual meeting, authorised the submission of a declaration to the ROC, which now has responsibility for this matter, to correct the figures reported in the annual returns for total members as at 31 December 2010-31 December 2016.

I refer to the documents lodged on 28 March 2013 providing information under section 233 of the **Fair Work (Registered Organisations) Act 2009**. In particular, I refer to the Declaration signed 28 March 2013 (see attached).

Sub-section 233(1)(b) requires the secretary to certify that the lodged *"copy of records required to be kept under paragraphs 230(1)(b), (c) and (d) is a correct statement of the information in those (i.e. the original) records."* The declaration signed 26 March might be read loosely as implying this, but on close reading, only states that the relevant copy of the records "have been annexed hereto". It is a fine distinction but, for the avoidance of doubt, I would ask that a brief supplementary declaration be provided to me by email, stating explicitly that the copy of the records lodged on 28 March 2013 is a correct statement of the information contained in those records.

I refer to the documents lodged on 26 March 2013 providing information under section 233 of the *Fair Work (Registered Organisations) Act 2009*, and to the additional documentation lodged on 2 May 2013 in relation to the keeping of the registers of members. There are two technical issues.

*Firstly*, sub-section 233(1)(a) requires the secretary to certify that the register of members “*has been kept and maintained as required by paragraph 230(1)(a) and subsection 230(2).*” The statement dated 30 April 2013 (see attached) only partly reflects this, in that it omits reference to subsection 230(2). Both section references are significant in that each provides for a particular aspect of the way registers must be kept and maintained and the Commission needs to have the Division’s confirmation that it has complied with both.

I note that the statements from five of the Branches refer to rule 50 or “the Union’s rule”, and that rule 50 reflects the requirements of both paragraph 230(1)(a) and subsection 230(2). These statements support the inference that the registers of members have been kept and maintained as required by the Act.

However, I note that the statements from three Branches – SA/NT, WA, and TAS - do not refer to rule 50 but to rule 29. I have not identified any rule 29 which directly relates to the maintenance of the register of members, and perhaps the Division can clarify this.

I would ask that, upon the Division being satisfied, a supplementary statement be provided by email to me, certifying that the register of members has also been kept and maintained ‘*as required by subsection 230(2)*’.

*Secondly*, sub-section 233(1)(b) requires the secretary to certify that the lodged “*copy of records required to be kept under paragraphs 230(1)(b), (c) and (d) is a correct statement of the information in those (i.e. the original) records.*” The statutory declaration signed 26 March (see attached) appears incomplete. It also purports to be made in accordance with section 233(2) and refers only to the information “*in relation to Regulation 147*” [i.e. pursuant to paragraph 230(1)(d)]

I would ask that an amended declaration be provided by email to me, made under “subsection 233(1)(b)”, completing the required statement “*in relation to paragraphs 230(1)(b), (c) and (d)*”. Errors and inadvertent omissions are avoided where the wording of the Act is closely followed.

Please contact me if there are any problems providing the declarations. I will file the documents upon receipt.



A declaration signed by a non-elected person does not meet this requirement. The Secretary or other prescribed officer must also notify the Commission within 35 days of any changes to such records.
