The Australian Electoral Commission has provided the Registered Organisations Commission (the ROC) a declaration of results for the election of uncontested offices in matter E2019/164. This letter is a reminder of certain obligations imposed on organisations and on persons elected to office.

#### A notice must be published on the organisation's website

The organisation or branch must, as soon as practicable after receiving the post-election report, publish on its website a notice that a copy of the report is available from the organisation, branch or the AEC on request. The notice must be kept on the website for a period of at least 3 months (see regulation 141 of the Fair Work (Registered Organisations) Regulations 2009).

#### Holders of office required to undertake approved training

Section 293K of the *Fair Work (Registered Organisations) Act 2009* (the RO Act) requires each officer with financial management duties to undertake approved training that covers those duties within 6 months after the person begins to hold office. Please ensure that relevant officers undertake approved training within the required timeframe. Rule 69 (a) states "In the event that any Branch Officer or Branch Committee of Management position becomes vacant for any reason and the unexpired part of the term is more than twelve (12) months or three quarters of the term of office before the date of the closing of the ballot for the next election whichever is the greater, the vacancy shall be declared vacant by the Branch Committee of Management at its next scheduled meeting following the occurrence of the vacancy. The election shall be conducted in the same manner and subject to the provisions of Rules 66 and 67."

Rule 67 (a) states "The ballot shall close at 12 noon on the thirtieth day of June in the year of the election or on the first working weekday following should the thirtieth day of June fall on a holiday or weekend and shall commence on the first day of June or the first working weekday following that date in the year of the election".

The Returning Officer altered the election dates, as the dates specified in the rules could not be adhered to due to the timing of the PI. The alternative election dates were negotiated with the Organisation.

With reference to the above, I attach:

• prescribed information for elections as required by 189(1) of the Fair Work (Registered Organisations) Act 2009 (the Act) and Regulation 138 Fair Work (Registered Organisations) Regulations 2009 (the Regulations);

The Communications, Electrical, Electronic, Energy, Information, Postal, Plumbing and Allied Services Union of Australia Communications Division, **Western Australian Branch** (the Branch) recently held scheduled quadrennial elections. As a result of those elections, Mr Alex Harris was declared elected to the Branch Committee of Management, representing members from the Telecommunications and Information Technology Industry Section.

Under Section D rule 65(a) of the CEPU rules covering the Communications Division, branch office holders take up office from the 1 August in the year of election following the declaration of the office. However, Mr Harris resigned his position on 29 July 2019 prior to taking up office on 1 August 2019.

The Communications, Electrical, Electronic, Energy, Information, Postal, Plumbing and Allied Services Union of Australia Communications Division, **Victorian Technical and Services Branch** (the Branch) recently held scheduled quadrennial elections.

Under rule 65(a) of the CEPU rules covering the Communications Division, branch office holders take up office from the 1 August in the year of election following the declaration of the office. Since taking up office, a member of the branch committee of management, Mr David Smithwick, resigned his position on 14 August 2019.

Rule 69 requires that an election be conducted where a Branch Committee of Management position becomes vacant for any reason and the unexpired part of the term is more than twelve (12) months or three quarters of the term of office before the date of the closing of the ballot for the next election, whichever is the greater. As further required by rule 69, the Branch Committee of Management at its scheduled meeting held 27 August 2019 declared the vacancy.

Accordingly, the Division requests that the Registered Organisations Commission (ROC) arrange elections to be conducted by the Australian Electoral Commission for the offices set out in the attached prescribed information.
