The Registrar is making arrangements, under subsection 189(3) of Schedule 1B of the *Workplace Relations Act 1996*, with the Electoral Commissioner for the conduct of the subject election by a member of staff of the Australian Electoral Commission, who will contact you in the near future about the election.

Please note that future requests of this nature should be lodged under section 189 of Schedule 1B of the *Workplace Relations Act 1996*. The attached Fact Sheet provides an overview of these requirements.

In particular, I draw your attention to regulation 138 of the *Workplace Relations (Registration and Accountability of Organisations) Regulations 2003* which provides that an organisation must lodge prescribed information two months before the date on which a person can become a candidate in an election. From the information you have provided concerning the proposed election for these positions, the date on which this information was required to be provided was two months before 27 November 2003, namely 27 September 2003. The Registry received this information on 21 October 2003. Your co-operation in adhering to these legislative timelines would be appreciated.
