

With reference to the above, I attach:

- prescribed information for elections as required by 189(1) of the *Fair Work (Registered Organisations) Act 2009 (the Act)* and Regulation 138 *Fair Work (Registered Organisations) Regulations 2009 (the Regulations)*;
- a copy of a request pursuant to s.187 for the Australian Electoral Commission (AEC) to conduct an election for a position other than office.

The Communications, Electrical, Electronic, Energy, Information, Postal, Plumbing and Allied Services Union of Australia Electrical, Energy & Services Division, Queensland and Northern Territory Branch (the Branch) currently has vacancies for an office of Branch Executive member for the Apprentice section, two Offices of State Councillor for the Apprentice Section, the position of Divisional Branch Conference Delegate for the Brisbane Sub-Branch and the position of Sub-Branch Secretary and Sub-Branch Vice President for the Ipswich Sub-Branch.



As these vacancies have occurred while “the unexpired portion of the term exceeds three-quarters of the term of the office” the Union is required under its rules to conduct an election (see Rule 16.3.2 of the registered rules of the Electrical, Energy and Services Division of the Communications, Electrical, Electronic, Energy, Information, Postal, Plumbing and Allied Services Union of Australia).

Accordingly, the Branch requests that the Registered Organisations Commission (ROC) arrange an election to be conducted by the Australian Electoral Commission for the offices and positions set out in the attached prescribed information. The nominations for the elections will open on dates to be determined in consultation with the AEC (see Rule 15.17.2). The roll of voters for these elections will close on 7 days before nominations open (see Rule 15.19.7).

PRESCRIBED INFORMATION FOR ELECTIONS in accordance with Section 189 *Fair Work (Registered Organisations) Act 2009* and Regulation 138 *Fair Work (Registered Organisations) Regulations 2009*

I, Peter Ong, being the Divisional Branch Secretary of the Communications, Electrical, Electronic, Energy, Information, Postal, Plumbing and Allied Services Union of Australia, Electrical Division, Queensland and Northern Territory Branch (the branch), make the following statement:

1. I am authorised to sign this statement containing prescribed information for the Branch.
2. The following information is being lodged under subsections 187 and 189(1) of the *Fair Work (Registered Organisations) Act 2009* (the RO Act);
3. The elections that are required are set out in the table in Annexure A;
4. The elections that are required are for:
 - a. a casual vacancy for an Office of Branch Executive member for the Apprentice Section caused by the Office Holder completing their apprenticeship and therefore no longer being eligible to hold the office;
 - b. a casual vacancy for two Offices of State Council in the Apprentice Section caused by the Office Holders completing their apprenticeships and therefore no longer being eligible to hold the office;
 - c. a casual vacancy for the position of Sub-Branch Vice President for the Ipswich Sub-Branch caused by a resignation of the position holder;
 - d. a casual vacancy for the position of Sub-Branch Secretary for the Ipswich Sub-Branch caused by a resignation of the position holder; and
 - e. a casual vacancy for the position of Divisional Branch Conference Delegate for the Brisbane Sub-Branch caused by a change in his employment, meaning he is no longer in the Brisbane Sub-Branch and therefore no longer eligible to hold the position.
5. A copy of the request for the AEC to conduct the election is attached;
6. No rule alterations are pending that will impact the election; and
