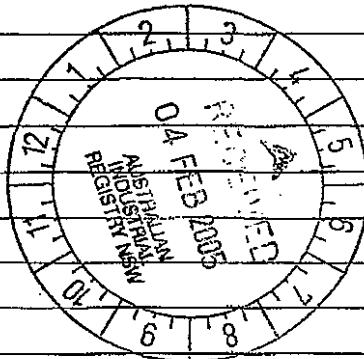

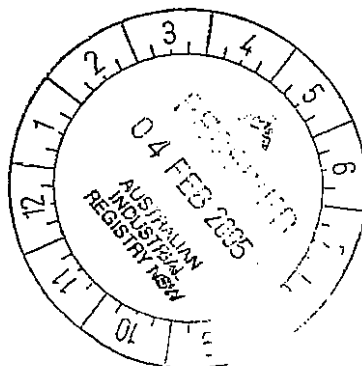

Election - Divisional and Branch Offices - Communications Division (E2005/30)

I refer to your notification regarding the above biennial elections lodged in the Registry on 4 February 2005.

Before I proceed to determine this matter, I seek your clarification and comment on the following questions.

- (1) The correctness of the numbers of Divisional Conference Delegates (and Alternates) cannot be ascertained without knowing the respective section and branch membership figures. These were not provided in the prescribed information. According to rule 5(d), there should be one Delegate for each 2000 members or part thereof. Please provide the relevant membership figures.
- (2) Similarly, the correctness of the numbers of Branch Committee Members requested in respect of the Operator Section in the South Australian/Northern Territory, Western Australian and Tasmanian branches cannot be ascertained without the section membership figures. According to sub-rule 76(h), the numbers of Operator Section representatives must be no less than 3 (or no less than 1 if the Operator membership is less than 250). The above membership figures will clarify this.
- (3) The prescribed information requests, for the Technical Section of the NSW Telecommunications & Services Branch, a single Branch Vice-President. Rule 76(f) specifies two(2). Do you agree that an election should be held for two Vice-Presidents from this Section?
- (4) The prescribed information includes, for the NSW Postal & Telecommunications Branch, a Branch President. A rule alteration currently before the Registrar proposes to alter this position to an honorary office. This position will only appear in my decision if the rule alteration is certified.
- (5) The prescribed information requests, for the Queensland Telecommunications & Services Branch, two (2) Vice-Presidents and indicates they are to be elected from the whole Branch membership, instead of one from each of the Technical and Operator Sections respectively, as provided for by rule 76(f). Do you agree that one Vice-President should be elected from each section?
- (6) The position of Branch Assistant Secretary is not included in the prescribed information for the South Australian/Northern Territory Postal & Telecommunications Branch. Rule 75(b)

states that each Branch management shall include an Assistant Secretary, and this position is not described as a full-time position. The records show that the position was not filled at the last two elections E2003/25 and E2001/36. Do you agree that rule 75(b) on its face appears to require this position in all the Branches? Can you clarify the status of this position and why the position is not being requested?

- (7) The prescribed information requests a Branch Assistant Secretary for the Tasmanian Telecommunications & Services Branch. However it is not provided for by rule 76(f). Do you agree that the election should not include this position?

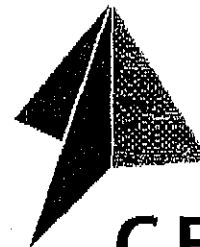

Question 6


