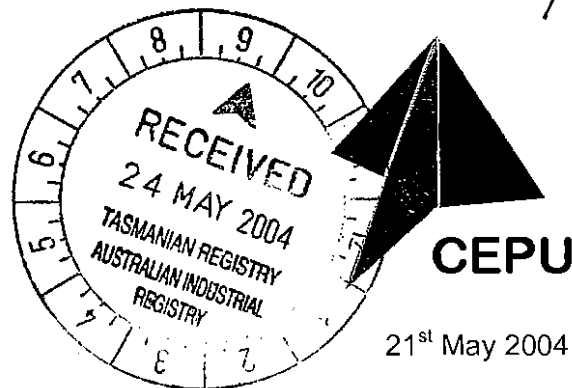

**Re: Arrangements for the conduct of an Election  
(E2004/189)**

Thank you for the lodgement of prescribed information for the conduct of an election for the position of Postal Group Representative, Branch Committee of Management.

Rule 70(d) of the Rules of the Communications Division provide for the Branch Committee of Management to fill vacancies by appointment if the unexpired portion of the term of office is less than twelve months or three quarters of the term of office, whichever is the greater.

As the position became vacant on 10 February 2004 and the two year term of office commenced on 1 August 2003, the vacancy has occurred in circumstances covered by Rule 70(d). Accordingly, I am not satisfied that an election is required to be held under the rules, therefore, I have decided not to grant the request for an election.
