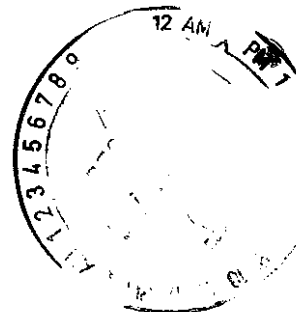

61. Prescribed information in respect of election - subsection 214 (1) of the Act

(1) For the purposes of subsection 214 (1) of the Act, the following information is prescribed information:

- (a) the name of each office in respect of which an election is required;
- (b) the reason for the election, being:
 - (i) that the term of the office has expired; or
 - (ii) that there is a casual vacancy in the office; or
 - (iii) that a new office has been created;
- (c) where more than one of the offices in respect of which an election is required has the same name and the number of such offices can, in accordance with the rules of the relevant organisation or branch, be ascertained before the prescribed day the number of those offices;
- (d) where the electorate comprises only members of a branch, section or other division of an organisation - the name of that branch, section or division, as the case may be;

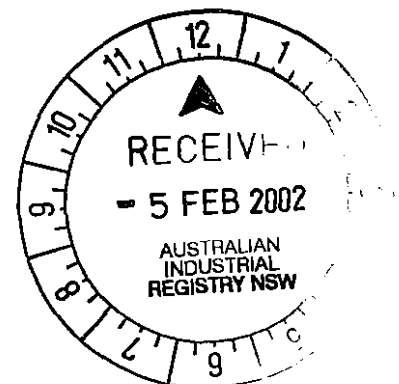

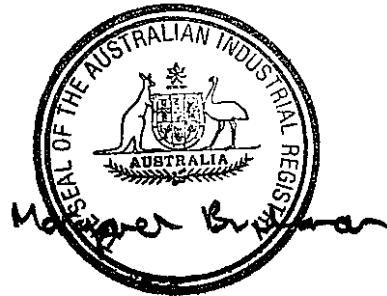

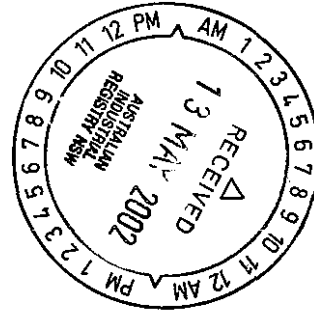
