**Reminder of actions required when persons elected to office**

The Australian Electoral Commission has provided the Commission a declaration of results for the election [E2015/161]. This letter is a reminder of certain obligations imposed on organisations and persons elected to office.

Section 154D(1) of the *Fair Work (Registered Organisations) Act 2009* (the RO Act) requires the rules of organisations (and branches of organisations) to require each officer with financial management duties to undertake approved training that covers those duties within 6 months after the person begins to hold office. Please ensure that relevant officers undertake approved training within the required timeframe.

Please also ensure that all new holders of office are advised of their obligations to make disclosures regarding remuneration, non-cash benefits and material personal interests, the details of which should be provided for in your organisation's rules.

Also, section 233(2) of the RO Act requires that an organisation must notify the Fair Work Commission (the Commission) within 35 days of any changes to the holders of office in the organisation. If the election has resulted in any changes to the holders of office, the Communications, Electrical, Electronic, Energy, Information, Postal, Plumbing and Allied Services Union of Australia-Electrical, Energy and Services Division - Tasmanian Divisional Branch must notify the Commission of these changes. In particular, please advise:

1. Person(s) who have ceased to hold office:
  - the name of the office vacated;
  - the date of the change of office holder; and
  - the name of the person vacating the office.
2. Person(s) who have commenced to hold office:
  - the name of the office now held;
  - the date of the change of office holder;
  - the name of the person now holding the office;
  - the postal address of the person (generally the postal address of the organisation); and
  - the occupation of the person now holding the office.

The notification must include a declaration by the Secretary (or other prescribed officer) that the information is a correct statement of the changes made. I have attached a template notification of changes which may assist you. If any change does not apply until a specific date, you don't need to notify until then (e.g. AGM, 1 January, 2nd Monday in March). If you have already lodged this information, please disregard this reminder.

*Arrangement for conduct of election.*

[1] On 12 May 2015 the Tasmanian Divisional Branch of the Electrical, Energy and Services Division of the Communications, Electrical, Electronic, Energy, Information, Postal, Plumbing and Allied Services Union of Australia (the CEPU) lodged with the Fair Work Commission (the Commission) the prescribed information in relation to an election for the following offices and non-office position:

[2] On 26 May 2015, the Commission wrote to the abovementioned Tasmanian Divisional Branch of the CEPU and requested confirmation of the number of Branch members to determine the number of Branch Delegates to the Divisional Council. The correspondence also stated that the abovementioned Branch was required to make a request to lodge the prescribed information on a later day as the prescribed information was lodged 6 days after the prescribed day.

[3] On 1 June 2015, the abovementioned Tasmanian Divisional Branch provided amended prescribed information and also made a request for an extension of time to lodge the prescribed information. The request provides that the delay in lodgement was due to an oversight regarding timing.

[4] With regard to the request for an extension of time for lodgement of the prescribed information, I have considered the explanation for the delay in lodging the prescribed information provided by Mr Gauld, the Branch Secretary. Having regard to the normal and reasonable expectation that registered organisations take steps to ensure that they comply with the time-frame requirements set out not only in the Act but also in instruments or references pertaining to the governance arrangements formulated by organisations themselves, I allow a later day for lodgement.

[5] While I have allowed a later day for lodgement in the circumstances of this application, the failure of an organisation to lodge prescribed information before the prescribed day contravenes section 189(2) of the Act and is a civil penalty provision which may be the subject of application by the Fair Work Commission for orders in the Federal Court.

[6] I am satisfied that an election for the abovenamed offices and non-office position is required to be held under the rules of the organisation and, under subsection 189(3) of the *Fair Work (Registered Organisations) Act 2009*, I am making arrangements for the conduct of the election by the Australian Electoral Commission.

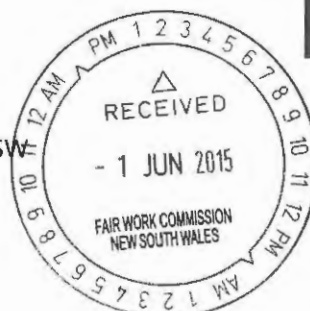

**E2015/161 – Arrangement for the conduct of an election for officers of the CEPU Electrical Division  
Tasmanian Branch**

Dear Mr Vale

I acknowledge receipt of your correspondence on 26 May 2015 regarding the lodgement of prescribed information for the conduct of a scheduled election for officers of the CEPU Electrical Division, Tasmanian Branch.

In response to your correspondence, I advise that the prescribed information lodged on 12 May 2015, that an election should be held for three (3) delegates to Divisional Council, is correct. However, the letter accompanying the prescribed information incorrectly stated the number of financial members of the three sections in the Branch as being 281, 389 and 776, which brought the total number of financial members below the threshold of 1500 required for the Branch to elect three delegates to the Divisional Council. Please note the correct number of financial members is 1,555 comprising:

- North West – 297 members
- North – 406 members
- South – 852 members

Pursuant to rule 7.3.2 of the Electrical Divisional rules, this number is in excess of 1500 entitling the Branch to three delegates to Divisional Council.

Further, in your correspondence it has been brought to my attention that pursuant to regulation 138(3) of the Fair Work (Registered Organisations) Regulations 2009, the prescribed information should be lodged two months before the first day a person may, under the rules of the organisation, become a candidate in the election. Section B rule 15.17.1 of the organisation's rules requires that nominations open on the first Monday in July, that is, the 6 July 2015. Due to an oversight regarding timing, the application to the FWC to arrange for the AEC to conduct the election was lodged within the prescribed two months. To comply with regulation 138(3) I request an extension of time pursuant to section 189(2) of the Fair Work (Registered Organisations) Act 2009.

**Arrangement for the conduct of an election - E2015/161**

I acknowledge receipt on 12 May 2015 of the prescribed information for the conduct of a scheduled election for offices of the Tasmanian Divisional Branch (the Branch) of the Electrical, Energy and Services Division (the Division) of the Communications, Electrical, Electronic, Energy, Information, Postal, Plumbing and Allied Services Union of Australia (the CEPU).

The prescribed information provides that an election should be held for three (3) Branch Delegates to the Divisional Council. The letter you have included with the prescribed information states that the number of financial members of the three sections in the Branch is 281, 389, and 776, which I calculate to add up to 1,446 members. Rule 7.3.2 of the CEPU's Divisional rulebook provides that one Delegate to the Divisional Council be determined where Branch members consist of below 1,500 members, and accordingly it appears that the number of Branch Delegates to the Divisional Council should be one (1) and not three (3). Accordingly, could you provide amended prescribed information for this office, or alternatively, provide additional information why you believe there should be three (3) Branch Delegates to the Divisional Council.

In addition, section 189(2) of the *Fair Work (Registered Organisations) Act 2009* (the Act) provides that prescribed information must be lodged before the "prescribed day" or such later day as the General Manager allows. Regulation 138(3) of the *Fair Work (Registered Organisations) Regulations 2009* defines the prescribed day as the day occurring 2 months before the first day when a person may, under the rules of an organisation, become a candidate in an election. As noted in the prescribed information, rule 15.17.1 of the Divisional rules provides that nominations shall open on the first Monday in July in the quadrennial election year. Accordingly, it appears that the relevant date for this year is 6 July 2015 and the prescribed day was 6 May 2015, which was 6 days after this prescribed information was lodged.

Accordingly, could you include a request to lodge the prescribed information on a later day, pursuant to section 189(2) of the Act. Once the requirements are met a Decision can be issued.

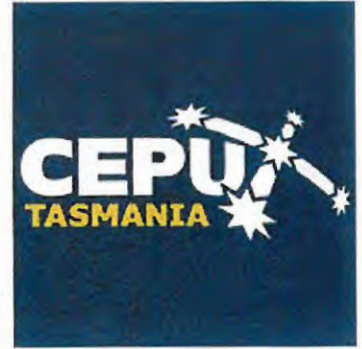

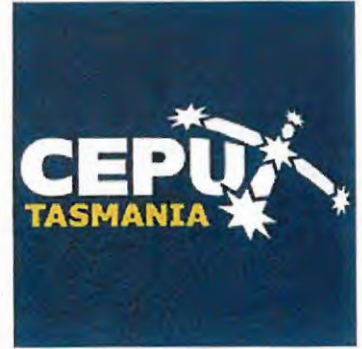
