I write with regards to the letter received from the Australian Electoral Commission (AEC) dated 19 August 2019 regarding the Declaration of the Communications, Electrical, Electronic, Energy, Information, Postal, Plumbing and Allied Services Union of Australia, NSW Divisional Branch (CEPU NSW Branch) ballot and your Post Election Report.

With regards to the Post Election Report and your comments on rules which are difficult to apply or interpret, the AEC identified two rules for consideration.

We note that in the 2015 AEC Post Election Report these same rules were not identified as difficult to apply or interpret.

However, the CEPU propose the following measures going forward:

Rule 22.7.11 – Subject to our internal processes and ratification by the CEPU Divisional Executive and the Registered Organisations Commission, the CEPU will recommend that the rule be amended to:

“All envelopes containing ballot papers received by the Returning Officer **by the close of the ballot ~~within seven days after the close of the ballot~~ shall be opened by him/her ~~in the presence of an official scrutineer~~ following the completion of the ballot count **and within seven days. An official scrutineer shall be entitled to scrutinise this process.**”**

Rule 23.1 – Subject to our internal processes and ratification by the CEPU Divisional Executive and the Registered Organisations Commission, the CEPU will recommend that the rule be amended as follows:

“In the event of there being more candidates than there are positions to be filled, a ballot shall be conducted on the preferential system. In any case where two or more candidates are to be elected, the multiple system of preferential voting shall be used. The voter shall vote for all candidates in the order of his/her preference but no vote shall be informal if a less number is voted for, provided the voter votes for at least **the same ~~one more than twice the~~ number of candidates to be elected in preferential order.”**

Our response to the AEC was also forwarded to the Registered Organisations Commission. We have received acknowledgment of our response from the AEC.

Thank you for your letter dated 19 August 2019 regarding the Declaration of the Communications, Electrical, Electronic, Energy, Information, Postal, Plumbing and Allied Services Union of Australia, NSW Divisional Branch (CEPU NSW Branch) ballot and your Post Election Report.

With regards to the Post Election Report and your comments on rules which are difficult or apply or interpret you have identified two rules for consideration.

We note that in the 2015 AEC Post Election Report these same rules were not identified as difficult to apply or interpret.

However, the CEPU propose the following measures going forward:

Rule 22.7.11 – Subject to our internal processes and ratification by the CEPU Divisional Executive and the Registered Organisations Commission, the CEPU will recommend that the rule be amended to:

“All envelopes containing ballot papers received by the Returning Officer **by the close of the ballot** ~~within seven days after the close of the ballot~~ shall be opened by him/her ~~in the presence of an official scrutineer~~ following the completion of the ballot count **and within seven days. An official scrutineer shall be entitled to scrutinise this process.**”

Rule 23.1 – Subject to our internal processes and ratification by the CEPU Divisional Executive and the Registered Organisations Commission, the CEPU will recommend that the rule be amended as follows:

“In the event of there being more candidates than there are positions to be filled, a ballot shall be conducted on the preferential system. In any case where two or more candidates are to be elected, the multiple system of preferential voting shall be used. The voter shall vote for all candidates in the order of his/her preference but no vote shall be informal if a less number is voted for, provided the voter votes for at least **the same** ~~one more than twice the~~ number of candidates to be elected in preferential order.”

We trust that these amendments will address the concerns of the AEC. If not, we are happy to continue consulting with the AEC.

Reminder of actions required when persons elected to office

The Australian Electoral Commission has provided the Registered Organisations Commission (the ROC) a declaration of results for the election of uncontested offices Stages 1 and 2 in matter E2019/66. This letter is a reminder of certain obligations imposed on organisations and on persons elected to office.

A notice must be published on the organisation's website

The organisation or branch must, as soon as practicable after receiving the post-election report, publish on its website a notice that a copy of the report is available from the organisation, branch or the AEC on request. The notice must be kept on the website for a period of at least 3 months (see regulation 141 of the Fair Work (Registered Organisations) Regulations 2009).

Holders of office required to undertake approved training

Section 293K of the *Fair Work (Registered Organisations) Act 2009* (the RO Act) requires each officer with financial management duties to undertake approved training that covers those duties within 6 months after the person begins to hold office. Please ensure that relevant officers undertake approved training within the required timeframe. Please also ensure that all new holders of office are advised of their obligations to make disclosures regarding remuneration, non-cash benefits and material personal interests, the details of which are provided for in the RO Act.

Organisation must notify the Commission of changes

Also, section 233(2) of the RO Act requires that an organisation must notify the Commission **within 35 days of any changes** to the holders of office in the organisation. **If there are no changes a notification is not required.** If the election has resulted in **any changes** to the holders of office, the Communications, Electrical, Electronic, Energy, Information, Postal, Plumbing and Allied Services Union of Australia - Electrical, Energy and Services Division - New South Wales Divisional Branch must notify the Commission of these changes. In particular, please advise:

1. Person(s) who have ceased to hold office:
 - the name of the office vacated;
 - the date of the change of office holder; and
 - the name of the person vacating the office.

2. Person(s) who have commenced to hold office:
 - the name of the office now held;

- the date of the change of office holder;
- the name of the person now holding the office;
- the postal address of the person (generally the postal address of the organisation); and
- the occupation of the person now holding the office.

The notification must include a declaration by the Secretary (or other prescribed officer) that the information is a correct statement of the changes made. A template notification of changes, which may assist you, is attached. If any change does not apply until a date in the future, you do not need to notify until then (e.g. AGM, 1 January, 2nd Monday in March). If you have already lodged this information, please disregard this reminder.

Organisation must respond to the post-election report of the Australian Electoral Commission: E2019/66

On 21 August 2019 the Registered Organisations Commission (the ROC) received a post election report from the Australian Electoral Commission (AEC) for election E2019/66. The AEC will have also provided the report to the organisation under section 197 of the *Fair Work (Registered Organisations) Act 2009* (the RO Act).

The report identifies rules that were difficult to interpret or apply, in particular Rules 22.7.11 and 23.1. This letter serves as a reminder of the obligations imposed on the organisation or branch as a consequence of the AEC's report. If a response has already been sent to the AEC and made available to all members please disregard this letter.

A notice must be published on the organisation's website

The organisation or branch must publish on its website a notice that a copy of the report is available from the organisation, branch or the AEC on request. The notice must be kept on the website for a period of at least 3 months (see regs 141(4) and (5)).

A written response must be provided to the AEC

A written response must be provided to the AEC within 30 days of receipt of the report. The organisation's response must include whether the organisation or branch intends to take action and if so what action the organisation or branch intends to take (s198(2)).

Extract of report must be made available to members

The organisation or branch must make the section of the report relating to the difficult rules available to its members (s198(3)). This extract from the report must be made available to the members before or at the same time as the organisation's response is made available to members.

Written response must be made available to members

A copy of the organisation's response to the AEC must be made available to members either:

- within 30 days after the response is given to the AEC, or
- published in the next edition of the organisation or branch journal (s198(5))

Subsection 198(6) and regulation 142 prescribe ways in which the relevant extract and the copy of the response can be made available to members. These do not limit the ways in which they can be made available to members. The organisation will comply if it does all of the following:-

- publish the report extract and the copy of the response in the next edition of the organisation or branch's journal; and
- within 30 days of giving the response to the AEC:
 - lodges with the ROC a copy of the relevant extract and response, together with a declaration that a copy will be provided to any member who so requests; and
 - give notice in the next edition of the organisation or branch's journal, or an appropriate newspaper, that a copy of the relevant extract and response are available on request to each member free of charge; and
- publish the relevant extract on the website within 14 days after receiving the report, and publish the response on the website within 14 days of giving the response to the AEC (reg 142(2)).

Penalties may apply

If the organisation or branch does not:

- respond to the AEC within 30 days,
- make the extract of the report relating to the rules available to members no later than the organisation's response is made available to members, or
- make the organisation's response available to members within 30 days or in the next edition of the journal,

the organisation may face penalties under the RO Act. Each requirement listed above is a civil penalty provision that may result in fines for the organisation

As noted above, if the response and report have already been made available to members and the AEC, please disregard this letter. If you have any questions in relation to these obligations please contact the ROC for assistance by email to regorgs@roc.gov.au.

If the organisation or branch decides to alter its rules in response to the AEC's report

If the organisation or branch decides to alter its rules in response to the AEC's report, the ROC is NOT able to provide advice and assistance regarding draft alterations or the processes required to make the alterations. Rule alterations remain a function of the Fair Work Commission.

Rules used for the election: [128V-NSW: Incorporates alterations of 18/04/2019 in R2019/38]

Rules difficult to apply/interpret: Rule 22.7.11 requires that all envelopes containing ballot papers be opened within seven days of the count in the presence of scrutineers. This is contrary to AEC policy as it does not allow for the preliminary scrutiny i.e. markback to the roll of voters. All ballot material received after the close of ballots is not opened and is parcelled so that it can be retained in accordance with Section 199 of the *Fair Work (Registered Organisations) Act 2009*

Rule 23.1 – The voting method to be used is multiple system of preferential voting where two or more candidates are to be elected. It states “the voter shall vote for all candidates in the order of his/her preference but no vote shall be informal if a less number is voted for, provided the voter votes for at least one more than twice the number of candidates to be elected in preferential order.” The rule is impossible to apply especially in a collegiate election where there are more than two candidates to be elected as there must be twice the number of candidates to apply the formula.

Reminder of actions required when persons elected to office

The Australian Electoral Commission has provided the Registered Organisations Commission (the ROC) a declaration of results for the election of uncontested offices in matter E2019/66. This letter is a reminder of certain obligations imposed on organisations and on persons elected to office.

A notice must be published on the organisation's website

The organisation or branch must, as soon as practicable after receiving the post-election report, publish on its website a notice that a copy of the report is available from the organisation, branch or the AEC on request. The notice must be kept on the website for a period of at least 3 months (see regulation 141 of the Fair Work (Registered Organisations) Regulations 2009).

Holders of office required to undertake approved training

Section 293K of the *Fair Work (Registered Organisations) Act 2009* (the RO Act) requires each officer with financial management duties to undertake approved training that covers those duties within 6 months after the person begins to hold office. Please ensure that relevant officers undertake approved training within the required timeframe. Please also ensure that all new holders of office are advised of their obligations to make disclosures regarding remuneration, non-cash benefits and material personal interests, the details of which are provided for in the RO Act.

Organisation must notify the Commission of changes

Also, section 233(2) of the RO Act requires that an organisation must notify the Commission **within 35 days of any changes** to the holders of office in the organisation. **If there are no changes a notification is not required.** If the election has resulted in **any changes** to the holders of office, the Communications, Electrical, Electronic, Energy, Information, Postal, Plumbing and Allied Services Union of Australia - Electrical, Energy and Services Division - New South Wales Divisional Branch must notify the Commission of these changes. In particular, please advise:

1. Person(s) who have ceased to hold office:
 - the name of the office vacated;
 - the date of the change of office holder; and
 - the name of the person vacating the office.

2. Person(s) who have commenced to hold office:
 - the name of the office now held;
 - the date of the change of office holder;

- the name of the person now holding the office;
- the postal address of the person (generally the postal address of the organisation); and
- the occupation of the person now holding the office.

The notification must include a declaration by the Secretary (or other prescribed officer) that the information is a correct statement of the changes made. A template notification of changes, which may assist you, is attached. If any change does not apply until a date in the future, you do not need to notify until then (e.g. AGM, 1 January, 2nd Monday in March). If you have already lodged this information, please disregard this reminder.
