Application Pursuant to Section 210 of the Workplace Relations Act 1996

I request that an election be conducted for the offices set out below under Section 210 of the Workplace Relations Act 1996, so as to ensure that no irregularity occurs in or in connection with the election.

The information required by regulation 61 for the purposes of sub-section 214(1) of the Act is as follows:

- a. The numbers of the offices in respect of which an election is required are set out in the attachment.
- b. The reason for the election of these positions is that the term of office expires 30th June this year.
- c. The electorate for the attached positions are the members of the relevant branch.
- d. The date of expiration whereby nomination of candidates must close is dealt with in Section C, Rule 49 of the CEPU Rules. Rule 49.4 states the last Monday in April, being the 28th April. The rules do not make provision for an opening date of nominations.
- e. The voting system to be employed in the conduct of the election is "first past the post."
