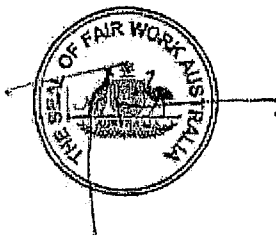

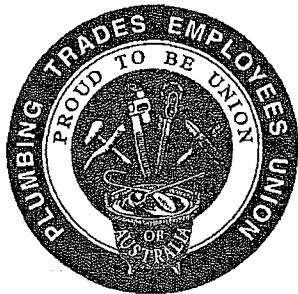

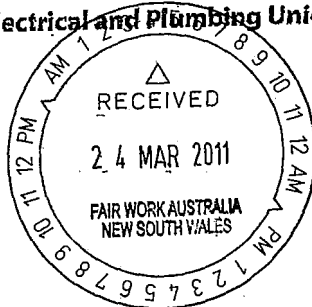

Elected by:

Nominations open:

- For offices to be elected by direct voting system - the first Monday in April

Nominations close:

- For offices to be elected by direct voting system – The last Monday in April

Cut off date for roll:

- In all cases - 7 days prior to the opening date for nominations - rule 49.9.(see note below)

Notes:

Given that the last Monday in April is a public holiday and there are a total of 3 Public Holidays in the period to nominate it may be necessary to change the date that nominations close (I suggest the last Friday in April). If the date is to change the closing date for nominations will not be in accordance with the rules. (Rule 49.4)

Rule 49.4

Nominations shall be called for by advertisement in a daily newspaper circulating in the State or Territory in which the Branch is situated. The closing date for nominations shall be the last Monday in April, 1995 and in each fourth year thereafter. Provided that any nomination may be withdrawn upon written notice of the nominee delivered to the Returning Officer within two weeks of the close of nominations.
