WA Plumbing Division of the CEPU has been registered as a separate organisation and rule changes have been put in place by both WA CEPU and CEPU Nationally to allow this to happen.

Rule changes came into effect 3rd of February 2014.

These rule changes allowed for the re-establishment of the Western Australian Branch of the Plumbing Division of the CEPU.

Lodgement of prescribed information by the Communications, Electrical, Electronic, Energy, Information, Postal, Plumbing and Allied Services Union of Australia, Plumbing **Division (E2014/67)** 

I refer to the prescribed information for an upcoming election of the Western Australian Divisional Branch (the Divisional Branch) of the Plumbing Division (the Division) of the Communications, Electrical, Electronic, Energy, Information, Postal, Plumbing and Allied Services Union of Australia which was lodged via email with the Fair Work Commission on 12 February 2014.

I wish to thank you for your prompt attention in lodging the prescribed information and note that the rule alterations re-establishing the Divisional Branch occurred on 3 February 2014. However, I would like to draw your attention to the following issues.

Rule 72 of the rules of the Division is a transitional rule which provides for the mechanisms to facilitate the re-establishment of the Western Australian Divisional Branch. Relevantly, sub-rule 72.5 provides that:

- "72.5 As soon as is practicable after certification date the Divisional President will request the Australian Electoral Commission to conduct an election for each of the following offices in the Western Australian Branch (the Western Australian Branch elections):
  - 72.5.1 Branch President:
  - 72.5.2 Branch Secretary;
  - 72.5.3 Six (6) Branch Committee of Management Members;
  - 72.5.4 Federal Vice President."

Sub-rule 48.2.3 which was also inserted into the rules of the Division in the alterations certified on 3 February 2014 provides that:

- "48.2.3 Despite sub-rule 48.2.1, the Committee of Management of the Western Australian Branch shall consist of of the following:
- (a) Branch President;

- (b) Branch Vice President (if any);
- (c) Branch Secretary;
- (d) Branch Assistant Secretary (if any);
- (e) Up to two Branch Trustees;
- (f) Branch Organiser/s (if any); and
- (g) not more than nine (9) other Committee members, the number of whom shall be determined by the Branch at Annual meeting or Special Meeting of the members;

and the question of whether an election is conducted for the office of Branch Vice President, Branch Assistant Secretary, Branch Trustee or Trustees and Branch Organiser at any election shall be determined by the Committee of Management prior to the election concerned."

The prescribed information provides that an election is required for only two (2) offices of Branch Committee of Management Member. This appears to be inconsistent with sub-rule 72.5 which provides that six (6) such offices are to be elected. In my view, given that rule 72 specifically deals with the transitional arrangements for the re-establishment of the Divisional Branch, it prevails over rule 48 which is a rule of general application in relation to the number of offices of Branch Committee of Management Member to be elected.

A further issue arises regarding the potential election of the offices of Branch Vice President and Branch Trustees. Sub-rule 72.5 does not provide for the election of such offices whilst sub-rule 48.2.3 does providing that the decision to establish such offices shall be determined by the Committee of Management of the Divisional Branch prior to the relevant election. Given that the Divisional Branch does not currently have a Committee of Management and that rule 72 specifically deals with the arrangements after the re-establishment of the Divisional Branch, there is a doubt regarding whether an election is required under the rules of the Division for the offices of Branch Vice President and Branch Trustees. In my view, sub-rule 72.5 details the requirements for the initial election to occur immediately after the re-establishment of the Divisional Branch whilst sub-rule 48.2.3 is a rule of general application which applies to any elections within the Divisional Branch after those initial elections have occurred.

In order to further progress this matter, could you please lodge amended prescribed information in light of my comments above or provide the advice of the Division if you do not agree with my comments.
