

whichever is later.

Any dues payable but not paid by a former member of the organisation, in relation to a period before the member's resignation from the organisation took effect, may be sued for and recovered in the name of the organisation, in a court of competent jurisdiction, as a debt due to the organisation.

A notice delivered to the State Secretary shall be taken to have been received by the organisation when it is delivered.

A notice of resignation that has been received by the organisation is not invalid because it was not addressed and delivered to the State Secretary.

A resignation from membership is valid even if it is not effected in accordance with this Rule if the member is informed in writing by or on behalf of the organisation that the resignation has been accepted.

## NOTES TO AND FORMING PART OF THE FINANCIAL STATEMENTS FOR THE YEAR ENDED 31 MARCH 2005

#### 1. ACCOUNTING POLICIES

The financial report is a general purpose financial report that has been prepared in accordance with Australian Accounting Standards, other mandatory professional reporting requirements and other authoritative pronouncements of the Australian Accounting Standards Board and the requirements of the Workplace Relations Act 1996.

The financial report covers the Communications Electrical Electronic Energy Information Postal Plumbing And Allied Services Union Of Australia as an individual entity. The Communications Electrical Electronic Energy Information Postal Plumbing And Allied Services Union Of Australia is a union operating in Queensland under the Workplace Relations Act 1996.

The financial report has been prepared on an accruals basis and is based on historical costs and does not take into account changing money values, or except where stated, current valuations of non-current assets. Cost is based on the fair values of the consideration applied, unless otherwise stated.

The following is a summary of the material accounting policies adopted by the entity in the preparation of the financial report. The accounting policies have been consistently applied, unless otherwise stated.

In particular:

- (a) The accounts have not been adjusted to record either changes in the general purchasing power of the dollar or in the price of specific assets other than as disclosed in these financial statements.
- (b) Plant and equipment are included at cost. All assets are depreciated over their useful lives. The Unions Peel Street property is valued in accordance with an independent valuation carried out on 13 February 2002. No depreciation has been charged against the Peel Street property during the year ended 31 March 2005.
- (c) No provision for income tax is necessary as Trade Unions are exempt from income tax under Section 50-15 of the Income Tax Assessment Act 1997.
- (d) Long service leave and retiring allowance accrued to officials up to 30 June 1999 is taken up in the books of the CEPU National Divisional Office. Long service leave and retiring allowance accrued to officials from 1 July 1999 is taken up in the books of the Queensland Branch.
- (e) As a sponsor of the BERT Fund the Union may receive distributions of income from the Fund. In accordance with the Sponsors Deed all distributions must be loaned back to the Fund until they are expended on welfare or related assistance as agreed upon by the Sponsors. The distributions from the Fund and welfare assistance paid from the loan account are not shown as income or expenditure of the Union as the Union has no control over the funds nor are the funds available for Union purposes.

## NOTES TO AND FORMING PART OF THE FINANCIAL STATEMENTS (continued) FOR THE YEAR ENDED 31 MARCH 2005

#### (f) Cash

For the purposes of the statement of cash flows, cash includes cash on hand, at banks and on deposit.

## (g) **Revenue**

Revenue from the rendering of a service is recognised upon delivery of the service to the members.

## (h) **Comparative Figures**

Where necessary, comparative figures have been adjusted to conform with changes in presentation in the current year.

## (i) Goods and Services Tax (GST)

Revenues, expenses and assets are recognised net of the amount of GST except where the amount of GST incurred is not recoverable from the Australian Tax Office. In these circumstances the GST is recognised as part of the cost of acquisition of the asset or as part of an item of the expense. Receivables and payables in the statement of financial position are shown inclusive of GST.

# 2. NOTICE REQUIRED UNDER SECTION 272 OF THE WORKPLACE RELATIONS ACT 1996

In accordance with the requirements of the Workplace Relations Act 1996, the attention of members is drawn to the provisions of Sub-Sections (1), (2) and (3) of Section 272 which reads as follows:

- (1) A member of a reporting unit, or a Registrar, may apply to the reporting unit for specified prescribed information in relation to the reporting unit.
- (2) The application must be in writing and must specify the period within which, and the manner in which the information is to be made available. The period must not be less than 14 days after the application is given to the reporting unit.
- (3) A reporting unit must comply with an application made under subsection (1).

#### Scope

We have audited the financial accounts of the Communications Electrical Electronic Energy Information Postal Plumbing and Allied Serviced Union of Australia for the year ended 31 March 2005 as set out on pages 1 to 9. The Union's Committee of Management and Accounting Officer are responsible for the preparation and presentation of the financial accounts and the information they contain. We have conducted an independent audit of these financial accounts in order to express an opinion on them to the members of the Union.

## Financial Return - year ending 31 March 2005 (FR2005/219)

I refer to the Branch financial documents lodged in the Registry on 2 August 2005.

There appear to be some omissions from the documents given to members. If so, the Branch may not have complied with all its financial reporting obligations for the following reasons.

#### Concise Report

Section 265(3) of the RAO Schedule<sup>1</sup> describes what a "concise report" must include. As you will see, the report consists of a number of elements including:

- a <u>concise financial report</u> drawn up "in accordance with the regulations" <sup>2</sup> regulation 161(1)(a) requires the concise financial report include specified financial statements presented <u>as in the full report</u> except for the omission of cross-reference to notes to the financial statements in the full report:
  - profit and loss statement (statement of financial performance) the copy in the concise report appears to differ from that in the full report; for example, the totals for income and expenditure differ
- the operating report (s265(3)(b))
- reports and statements mentioned in s253(2)(c) specifically a copy of the Committee of Management Statement - see regulation 161(1)(d)
- the notice mentioned in s272(5) -- see regulation 161(1)(f)
- discussion and analysis of the principal factors affecting the Branch's financial performance, financial position and financial and investing activities to assist the understanding of members – see regulation 161(1)(c)

Subject to any comments the Branch may wish to make, it does not appear to have provided its members a copy of a concise report which complies with the legislation<sup>3</sup>.

#### **Operating Report**

The Branch has included the text (slightly paraphrased) of what appears to be rule 18 of the rules of the Plumbing Division of the CEPU. To avoid any doubt and to ensure that details given are completely consistent with the rules, the Branch may wish to consider inserting the exact text of the relevant rule as set out in the rules of the Division in future reports. Alternatively, a form of words such as "Rule xx of the rules of the Plumbing Division of the CEPU sets out members' right to resign from the Branch" is acceptable as long as the correct rule number is cited and the correct Division's rulebook cited.

#### Committee of Management Statement

#### Consistency

The reporting Guidelines of the Industrial Registrar require the Committee to express its opinion on various matters including whether "where the organisation consists of 2 or more reporting units, the financial records of the reporting unit have been kept, as far as practicable, in a consistent manner to each of the other reporting units of the organisation".

As you would appreciate, the Branch is one of many reporting units (other branches, divisions and so on) which make up the registered organisation known as the CEPU. Section 252(2) requires each of these reporting units to keep financial records in a consistent way as far as practicable. The Committee must express its view on whether the Branch has done so. In its Statement the committee has omitted to express its opinion. Please ensure the Committee does so in next year's Statement.

#### Date of Statement

Please also ensure the date of the resolution of the Committee is also stated on next year's Statement.

#### Signatory of Statement

Section 243 defines who is a "designated officer" under the Guidelines for the purpose of signing the Statement – this is the officer who, under the rules of the Branch, is responsible for undertaking the functions necessary to enable the Branch to comply with its financial reporting obligations. This would appear to be, under the rules of the Division, the Secretary of the Branch. If so, please ensure the Statement is signed by the Secretary in future.

#### Audit Opinion

The auditor has expressed his opinion on the financial report by reference to the former provisions (s253) of the Workplace Relations Act 1996. Under s257(5) of the RAO Schedule an auditor must:

state whether in the auditor's opinion the general purpose financial report is presented fairly in accordance with any of the following that apply in relation to the reporting unit:

(a) the Australian Accounting Standards;

(b) any other requirements imposed by this Part.

If not of that opinion, the auditor's report must say why.

Could you please draw this to the auditor's attention when preparing next year's report.

Under "Scope" the auditor has referred to the "accounting officer" of the Branch – the term "accounting officer" is no longer used under the RAO reporting provisions.

#### Further Action

As discussed by phone today, the Branch should now arrange to provide either a copy of the full report (the general purpose financial report, the operating report and the auditor's report) to its members or a copy of a complete concise report.

If the Branch chooses to provide the full report, it could do so by posting a copy on its website and advising members of its availability there. If the Branch chooses to present the full report to a general meeting of members, it must provide the report at least 21 days before the meeting. After the full report has been presented to the general meeting, the Branch should lodge a copy in the Registry with your certificate. A copy of a draft certificate was enclosed in the Registry's letter of 12 April 2005.

Please ensure the dates of provision to members (by posting on the website) and presentation to the general meeting are specified in the certificate.

It should not be necessary to lodge a new set of documents in the Registry as copies of the general purpose, operating and auditor's reports have been lodged already. However, when you lodge your certificate, please confirm that the documents already lodged are the same as those provided to members and presented to the meeting.

Could you also please confirm what action the Branch now plans to take to complete its reporting obligations.


