Please note that the following information is intended as a reminder only. No notification is necessary for election E2019/228, as no nomination was received.

Reminder of actions required when persons elected to office

The Australian Electoral Commission has provided the Registered Organisations Commission (the ROC) a declaration of results for the election of uncontested offices in matter E2019/228. This letter is a reminder of certain obligations imposed on organisations and on persons elected to office.

A notice must be published on the organisation's website

The organisation or branch must, as soon as practicable after receiving the post-election report, publish on its website a notice that a copy of the report is available from the organisation, branch or the AEC on request. The notice must be kept on the website for a period of at least 3 months (see regulation 141 of the Fair Work (Registered Organisations) Regulations 2009).

Holders of office required to undertake approved training

Section 293K of the *Fair Work (Registered Organisations) Act 2009* (the RO Act) requires each officer with financial management duties to undertake approved training that covers those duties within 6 months after the person begins to hold office. Please ensure that relevant officers undertake approved training within the required timeframe. Please also ensure that all new holders of office are advised of their obligations to make disclosures regarding remuneration, non-cash benefits and material personal interests, the details of which are provided for in the RO Act.

Organisation must notify the Commission of changes

Also, section 233(2) of the RO Act requires that an organisation must notify the Commission **within 35 days of any changes** to the holders of office in the organisation. **If there are no changes a notification is not required.** If the election has resulted in **any changes** to the holders of office, the Communications, Electrical, Electronic, Energy, Information, Postal, Plumbing and Allied Services Union of Australia - Electrical, Energy and Services Division - South Australian Divisional Branch must notify the Commission of these changes. In particular, please advise:

1. Person(s) who have ceased to hold office:

- the name of the office vacated;
- the date of the change of office holder; and
- the name of the person vacating the office.

2. Person(s) who have commenced to hold office:

- the name of the office now held;
- the date of the change of office holder;
- the name of the person now holding the office;
- the postal address of the person (generally the postal address of the organisation); and
- the occupation of the person now holding the office.

The notification must include a declaration by the Secretary (or other prescribed officer) that the information is a correct statement of the changes made. A template notification of changes, which may assist you, is attached. If any change does not apply until a date in the future, you do not need to notify until then (e.g. AGM, 1 January, 2nd Monday in March). If you have already lodged this information, please disregard this reminder.



Arrangement for conduct of election.

CEPU Electrical, Energy & Services Division - SA Branch Election to fill a Casual Vacancy 2019

With reference to the above, I attach:

- prescribed information for an election as required by 189(1) of the *Fair Work (Registered Organisations) Act 2009 (the RO Act)* and regulation 138 *Fair Work (Registered Organisations) Regulations 2009 (the Regulations)*; and

The Communications, Electrical, Electronic, Energy, Information, Postal, Plumbing and Allied Services Union of Australia, Electrical, Energy & Services Division, South Australian Branch (the Branch) is required to conduct an election to fill a casual vacancy caused by the resignation of a State Councillor representing the electrical supply section.

An election for this office was declared by the AEC on 24 July 2019. The office holder resigned from this office on 28 November 2019. Rule 16.3 of Section B of the CEPU rules requires an election to be conducted where the occupant of an office within a divisional branch resigns and:

- 16.3.2 *Where the unexpired portion of the term exceeds three-quarters of the term of the office or if it is less but the State Council so decides, an election shall be held to fill the office. Such election shall be conducted in accordance with the relevant provisions of rule 15 "Elections" and shall be commenced within six (6) months of the vacancy occurring. The successful candidate shall hold office for the unexpired term of their predecessor unless he/she resigns, dies or is removed from office in accordance with the rules.*

As the unexpired portion of the term of the office exceeds three quarters of the term of office, rule 16.3.2 requires an election to be conducted. Pursuant to section 182 of the *RO*

Act, the Australian Electoral Commission (AEC) must conduct the election for this office. Accordingly, the Branch requests that the Registered Organisations Commission arrange an election to be conducted by the AEC for this office as set out in the attached prescribed information.
