Dear Mr Donnelly,

I refer to the financial statements and accounts for the year ending 31 December 2011 which were lodged with Fair Work Australia on 19 March 2012.

I need to clarify with you the way the Branch Committee arranges its meetings to comply with the Act in the matters of (1) providing copies of the report to members and then (2) presenting it in accordance with section 266.

In your Secretary's Certificate you state that the report was "provided to members" on the 14<sup>th</sup> March 2012, and then subsequently presented to the State Executive and the State Council on 14 March 2012. A discrepancy occurs in your covering letter in which you state that the report and its attachments "will be available on the website from the 16<sup>th</sup> March 2012". Both the certificate and the letter are dated 15 March.

If I look back at previous years' returns, I see that from the 2005 through to the 2009 reports, the Certificate indicated that the report was presented to the State Executive at a second meeting after the documents were provided to members. (e.g. the 2005 report was approved on 8 March 2006, was distributed in the News from 1 April 2006, and was presented on 10 May 2006). This was the correct sequence which the Act has required. The reason is that what the members should receive or see on the website should be documents that are already signed – this explains the concept of a "first" Committee meeting. And it is only once the members have received or had access to the signed report that the Committee can properly "present" the report in the sense meant by s266 of the Act – this explains the concept of a "second" Committee meeting.

In 2010 and now, in this latest return, the Certificate has indicated that everything is signed and presented on the same day, and that the members had the documents available on the website only after it was presented.

The Act's intention is that members can be satisfied that their financial affairs have been audited and they have had a chance to raise any queries. This is why the sequence is best understood as (1) prepare the documents and have them signed at a first Committee meeting; (2) arrange to make the documents available or sent out to members; (3) hold a second Committee meeting and formally "present" the documents; (4) sign the Certificate and lodge everything with FWA.

Can you consider this and confirm that you do not anticipate difficulties being able to comply in respect of future financial reporting years? If you wish to discuss any aspect of this, please feel very welcome to contact me on 02 6723 7097 or 0429 462 979 this afternoon.

## OPERATING REPORT

This Operating Report covers the activities of the Communication Electrical Plumbing Union, Electrical Energy and Services Division, South Australian Branch, for the financial year ended 31 December 2011.

1. Principal Activities of the Branch

Over the year, the Branch has negotiated new Union Collective Agreements and renewed scores of existing Union Collective Agreements.

The Branch has also been involved in negotiations with different levels of Government around issues of importance to CEPU members. An example of this is the Branches participation in campaigns to abolish the Federal Australian Building and Construction Commission legislation.

Vocational training continues to be a priority involving:

- Representation on the state Electrotechnology Electrical Energy and Water Industry Skills Board (EWSB).
- Representation on the Construction Industry Training Board (CITB) (Board fees paid to the union).
- Representation on the Plumbing Electrical Electronic Refrigeration Vocation Education Employment Training (PEER VEET) Board.
- Representation on the Construction Industry Long Service Leave Board (Board fees paid to the union).
- Representation on the Building Industry Redundancy Trust (Board fees paid to the union).
- Manufacturing Industry Skills Advisory Council

#### 2. The Branch's Financial Affairs

There were no changes to the financial affairs of the union..

Right of Members to Resign.

All Members of the Branch have the right to resign from the Union in accordance with Section B Electrical Division Rule 4.6; namely, by providing written notice addressed and delivered to the Secretary of the Branch, including by facsimile.

4. Superannuation Trustees.

The Union is represented by Bob Donnelly, who is an appointed trustee director on the Electricity Industry Superannuation Scheme, which operates in the privatised Power Industry (no Board fees paid).

#### 5. Membership of the Branch.

There were 3,819 members of which 3,211 were financial members of the Branch as at 31st December 2011.

I have audited the accompanying financial report, being a general purpose financial report which comprises the balance sheet as at 31st December 2011, the income statement and cash flow statement for the year then ended, a summary of significant accounting policies, and other explanatory notes as set out on pages 14 to 17.

#### 1. ACCOUNTING METHODS

The financial statements have been prepared in accordance with applicable Accounting Standards, other mandatory professional reporting requirements (Urgent Issues Group Consensus Views) and the Fair Work Act 2009. The financial statements have also been prepared on the basis of historical costs and do not take into account changing money values or, except where stated, current valuations of non-current assets. The accounting policies have been consistently applied, unless otherwise stated.

The following is a summary of the significant accounting policies adopted by the economic entity in the preparation of the accounts:

- (a) Depreciation of fixed assets is calculated on both the straight line and diminishing value basis in order to write the assets off over their useful life.
- (b) Provision for employee benefits in the form of accrued Long Service Leave and Annual Leave have been made for the estimated accrued entitlements of all employees on the basis of their terms of employment. In the case of Long Service Leave, the accrual has been measured by reference to periods of service and current salary rates, as it is considered that this results in an amount not materially different to that achieved by discounting estimated future cash flows.
- (c) No provision for income tax is necessary, as industrial "Trade Unions" are exempt from income tax under Section 50.15 of the Income TaxAssessmentAct 1997.

# Lodgment of Financial Statements and Accounts – South Australian Branch (Electrical, Energy & Services Division) - for year ended 31 December 2011 (FR2011/2835)

The financial year of the South Australian Divisional Branch has recently ended. This is a courtesy letter to remind you of the obligation to prepare the reporting unit's financial documents and to lodge audited financial accounts and statements with Fair Work Australia within the prescribed time frame unless a 1 month extension is applied for and granted.

The documents you must lodge include:

(i) A <u>general purpose financial report</u> [see section 253(2)]; (ii) A <u>Committee of Management statement</u> (see the General Manager's Reporting Guidelines); (iii) An <u>operating report</u> [see section 254(2)]; (iv) An <u>auditor's report</u> [see sections 257(5) to 257(11)]; and (v) A <u>certificate</u> of the secretary or other designated officer [see section 268(c)].

I draw your particular attention to

(a) s237 which requires you to prepare and lodge *a separate statement* providing the prescribed particulars of any loan, grant or donation made during the year which exceeds \$1,000;

(b) s265(5) which requires you to publish or otherwise *provide your members with completed/signed copies* of the audited accounts, report and statements before final presentation and lodgment; and

(c) s266 which requires you to <u>present the completed documents to a second meeting</u>. Note that this meeting is distinct from any initial committee meeting convened to prepare, sign or otherwise approve pre-audited documents.
