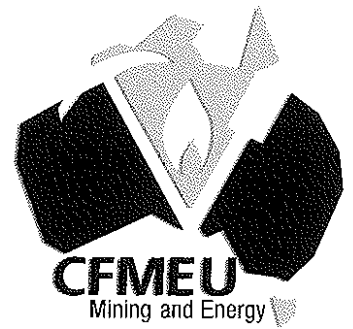

- The CFMEU had 103,000 members and employees or independent contractors as at the 31 December 2008.


6. There are elections planned under the CFMEU rules for the year commencing 1 January 2009.
