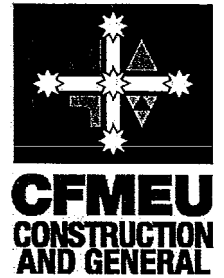



3. That I certify that the register of members has, during the immediate period preceding calendar year (2011), been kept and maintained as required by subsections 230(1)(a) and (2) of the Fair Work (Registered Organisations) Act 2009 [FW (RO) Act] for all branches of the abovementioned organisation.

 - Under the rules of the CFMEU Forestry & Furnishing Products Division, in the year commencing 1 January 2012, elections will be held for the Offices within Divisional Branches and National Divisional Officers in October 2012.
7. In accordance with section 230(1)(d) and reg. 147(b) no new branches have commenced in the year to 1 January 2012.
8. In accordance with section 230(1)(d) and reg. 147(c) no branches have ceased operation in the year to 1 January 2012.
