I note that this declaration is made outside of the time allowed for such declarations under s.233 of the Act, and we ask that the General Manager extend the time allowed for lodgement.

The reason for the delay in lodgement is made up of a combination of factors including the absence of both the Branch Industrial Officer and one of the Branch Legal Officers on maternity leave at the relevant time and for some months thereafter, and various matters associated with the Union's need to respond to a large number of matters arising out of the Trade Union Royal Commission. These factors meant that our remaining legal and administrative staff were not able to turn their attention to this matter in as expeditious a manner as would have been desirable.

In short, the pressure of circumstances led to this matter being overlooked.

We apologise for the delay and advise that in February and March 2016 the Branch has conducted an internal review of its governance and administration procedures relating to Fair Work Act compliance, with a view, among other things, to ensuring that such delays do not occur in future. We advise that our failure to provide this notice in a timely manner came to light in the course of that review. We have taken steps to ensure that all relevant staff and officers are cognisant of the obligation to advise the Commission of any further changes in the office holders of the Branch.

In the circumstances, it appears that no prejudice will arise to any person as a result of the delay and we ask that the declaration be accepted.
