Dear Ms. O'Neill,

The Maritime Union of Australia, Division of the Construction, Forestry, Maritime, Mining and Energy Union (MUA), has recently completed its Quadrennial Election for all the relevant Offices of the Division for the term of 2019 to 2023. The Election was held in accordance with the provision of the Fair Work (Registered Organisations) Act 2009, with the MUA granted a continuing exemption to conduct its own ballot as prescribed by Section 186(i) of that Act. The procedures applied for the conduct of the Election were undertaken in conformity with the MUA's Divisional Rules as last certified on 21 December 2018.

The MUA had 12,839 members of which, 12,286 (96%) were financial when the Final Roll of Voters was compiled on 15 February 2019 in accordance with Divisional Sub-Rule 46(b). Nominations for all positions opened on 25 February 2019 [comprising 5 Divisional National positions (1 Honorary) and 26 Branch positions (5 Honorary)] to be contested.

When nominations closed at 5.00pm Monday 25 March 2019, 46 nominations had been received and each of these nominations were vetted and 45 were found to comply with Divisional Sub-Rule 45(g). One nomination was declared invalid as it did not comply with Divisional Sub-Rule 45(g).

Three Officers had previously given notice that they were not going to nominate for election to Office and two other Officers had given notice that they were intending to nominate for a different Office in conformity with Divisional Sub-Rule 45(i).

Twenty positions were uncontested, and those Candidates were elected unopposed. A ballot was required to determine the remaining eleven positions which were contested collectively by twenty-five Candidates.

The ballot was conducted as a postal vote of all members listed on the Final Roll. The duration of the ballot extended from the posting out of Ballot Papers and Candidate Information material on and from 29 April 2019 until the close of the ballot on 14 June 2019.

The counting of the Ballot took place between 17 to 20 June 2019, with Scrutineers in attendance on each day. At the conclusion of the Count there was no call for a Recount of any Office and No Protest was notified by any Candidate.

The National Participation rate was 48.5%. The three Branches with the highest participation rate were Victoria, Sydney and Queensland.

All successful Candidates took office on 1 July 2019.

I attach herewith a more detailed Divisional National Returning Officer's Report provided to the National Secretary as well as a copy of the Final Count and Declaration of the Poll for your information.

## **Divisional Quadrennial Election Report 2019 – 2023**

The Divisional Quadrennial Election for the term 2019-2023 has concluded with newly elected Officials and unopposed Officials taking office on 1 July 2019.

The 2019 Divisional Quadrennial Election concluded on Friday 21<sup>st</sup> June 2019 with the Declaration of the Ballot made on Wednesday the 26<sup>th</sup> June 2019 to the Divisional National Secretary and Branch Secretaries in accordance with the MUA Divisional Rules.

The MUA Division conducted the Ballot itself by way of the exemption granted to it which remains in force pursuant to section 186(1) of the Fair Work (Registered Organisations) Act 2009.

When the Final Roll was prepared on February 15<sup>th</sup>, the total membership totalled 12,839, of which 12,286 were financial and entitled to vote. 12,286 were listed on the Final Roll.

There were 31 official positions to be filled which included 5 National, one of which is Honorary, and 26 Branch positions, of which 5 are Honorary.

In conformity with Divisional Sub-Rule 45(i), 3 Officers gave written notice that they were not intending to nominate for election to office and 2 Officers gave notification that they were intending to nominate for a different Office.

46 nominations were received at the World Square Post Office at the close of nominations and 45 were found to comply with MUA Divisional Rule 45. One Nominee had a complaint lodged by a financial member, alleging that the Nominee failed to comply with the requirements of Divisional Sub-Rule 45(g). The Divisional National Returning Officer subsequently made enquiries of that Nominee and gave the Nominee adequate time to provide evidence of compliance with Divisional Sub-Rule 45(g). The Divisional National Returning Officer, having carefully considered the several responses provided, ultimately determined that the Nominee was ineligible to nominate for the relevant Branch Office.

The Candidate's 200 word statement and photograph (in colour), where provided, were published on the MUA Website and printed copies were provided for members to access at Branch Offices and National Office well in advance of being sent out with the Ballot Materials.

## Uncontested Positions

There were 20 positions uncontested and these candidates were elected unopposed. 25 candidates contested the remaining 11 positions. There were 4 National positions and 16 Branch positions that did not require a ballot, as those officials were elected unopposed:

## **Provision of Electoral Roll**

The provision in Divisional Sub-Rule 46(d) of the MUA Divisional Rules recognising the right of members to “opt out” of receiving communications from Candidates resulted in a posting of a Notice on the MUA Election Webpage giving members this choice in advance of copies of the Electoral Roll being provided to Candidates who sought them. 8 members chose to exercise this option. All 8 members has their details redacted from the copy of the Roll supplied to Candidates.

8 Candidates sought copies of the Final Roll, which were mainly provided in electronic format (USB) but also in paper form. Given that the Election count is finalised, I will write to all Candidates seeking they either return the Electoral Roll provided or alternately that they provide a written undertaking that they have destroyed or erased that data or information which was provided to them.

## **Ballot Papers**

Ballot papers were posted to all members on the Final Roll from 29 April 2019 in accordance with the MUA Divisional Rules.

The participation rate for this election of returned ballot materials was 48.5% of members on the Final Roll. This is an improvement on the figures for the 2015 Election (47%) and has arrested a decline from the elections prior to 2011. Three branches requiring a Branch and National election had the highest participation rate (Victoria, Sydney and Queensland).

In the period between the close of Nominations and the printing of the ballot papers we were able to amend the addresses of 107 members on the Final Roll as a result of notices sent to members on the MUA Website and by SMS and Branch activity.

Facility to assist in maximising participation in the Ballot was offered to members and we received 272 requests for Ballot materials (164 Ballot Replacement requests and 108 Absentee Voting requests) for which we sent out fresh ballot materials. Arising from the number of requests we received 240 returned 2<sup>nd</sup> ballot envelopes admitted to the Count. None of these requests resulted in more than 1 vote (National and/or Branch) being accorded to any single member (i.e. no one could “double dip”).

Furthermore, we received (sent back to us) 242 Election envelopes which were ‘Return to Sender – Not at this Address’ during the Ballot Period. We attempted to make contact with each one of these members (via mobile phone, home phone, work phone or email) in an endeavour to resend their ballot materials. Of this number we were able to resend 94 of those envelopes back to alternate addresses given to us by the members.

Members on the Final Roll who resign or have their membership cancelled prior to the close of the Ballot shall not be eligible to vote [Divisional Sub-Rule 46(c)].

Consequently 9 of the 138 members who were affected by this Rule, had their vote blocked at the Count of the Ballot (the others did not vote).

During the period of the ballot, some ships' delegates contacted the Divisional Deputy Returning Officer to enquire about getting ballot papers forwarded to crew members who would not be home to vote and those Delegates had the Member provide a postal address for where we could re-direct the ballot papers through the Absentee Voting procedures. These Absentee Voting papers were then forwarded to a nominated address, usually to the Ships Agent in a visiting port who would provide the Ballot Materials to the relevant Members on board the vessels.

The following worksites were contacted by us to offer assistance in urging members to participate in this Election and to obtain absentee voting where necessary:

All Tug delegates (Svitzer, Teekay and PB Towage); Sydney Ferries;

All FPSO Installations; DP World Terminals, Patrick Stevedores;

Kalmar Maintenance; All of the Toll Fleet; all of the Searoad Fleet;

The Ocean Protector; RTM Twarra; the two Spirit of Tasmania Vessels;

RTM Weipa, RTN Wakmartha and RTM Pilramu

NSW Coal and Grain Terminals;

MV Accolade II; MV Goliath

As well as Election Webpage notices, we also sent out numerous SMS messages and emails to members urging that they update their financiality and contact details with the Branches and urging their participation in the Election Process.

As the close of the Ballot period approached, two members sought replacement ballot papers be provided and voted by attending the National Office to vote in person. Each such member cast their vote in privacy ensuring the secrecy of the ballot. Each sealed Declaration Envelope was then included in the postal pick-up.

Security arrangements for the protection of the Ballot Papers is extremely important. On this occasion we were fortunate that Mark Gonovese from the Unity Bank offered the use of secure and protected storage for our Nominations received, which were stored in their Sydney Branch Office, and for our Ballot Materials, which were stored at Head Office in Clarence Street, Sydney.

Thirteen (13) Scrutineers represented fourteen (14) Candidates during the Count and played a vital and constructive role in representing their Candidates interests.

## **Inquiries**

During the period of the Ballot I was contacted by several Candidates who put me on Notice of possible breaches of section 190 of the Fair Work (Registered Originations) Act 2009 (the Act), concerning alleged use of Union Resources or Property to advantage one candidate over another candidate for office.

I took legal advice as to the extent of my powers under the Divisional Rules to deal with these allegations. Notwithstanding, in each case I made enquiries and investigated the allegations and afforded all parties ample opportunity to respond to my enquiries. In each instance I formed the view that each allegation/complaint had no evidentiary basis and I therefore declined to further deal with each matter unless new or persuasive evidence could be provided. However, I sent an email to all Candidates who were existing Officers, reminding them of their obligations pursuant to section 190 of the Act and asked them to be vigilant to ensure compliance with that provision.

## **Summary of Outcome**

I attach hereto several tables which provide data summary of the outcome of the Election with respect to National Office, Branches and Candidates.



## **Conclusion**

I would like to congratulate all Candidates, successful or otherwise, for their participation in the election process. This election has given the leadership team a blend of new talent and has retained experienced and skilled Officers, all highly capable and suited to lead the Union in the years ahead.

Lastly, I need to place on record the immeasurable assistance I have received from Divisional Deputy Returning Officer Neil Swanson. I cannot sufficiently express my gratitude for all the work that Neil has contributed towards the outcome of the process. He was constantly in contact with the membership, the Candidates, the Delegates and the Branch Staff in processing all the inquiries we received, facilitating changes of address, sending out Replacement Ballot Papers and Absentee Votes and the myriad of other matters that needing attending to. His assistance was invaluable, and I am sincerely thankful for his significant contribution.

I cannot conclude without acknowledging the assistance of George Zorbas, Ella Rowe, Lynne Holland and Karyn Pietens. They helped me on every occasion that I required tasks to be completed and in particular when I needed technical assistance. I am indeed grateful to each of them. I also wish to recognise the assistance provided by the various Branch Staff members around the country who were the primary conduit between the Members who sought assistance and the Divisional Returning Officers. They contributed significantly to us facilitating a higher participation rate than might otherwise have been the case.

I also want to thank the staff at the Divisional National Office and the ITF who temporarily set aside a significant amount of their usual duties to allow themselves to participate in the Count of the Ballot. I very much appreciate their care and diligence with the performance of these tasks, which is so important to ensuring the accuracy of the final results.

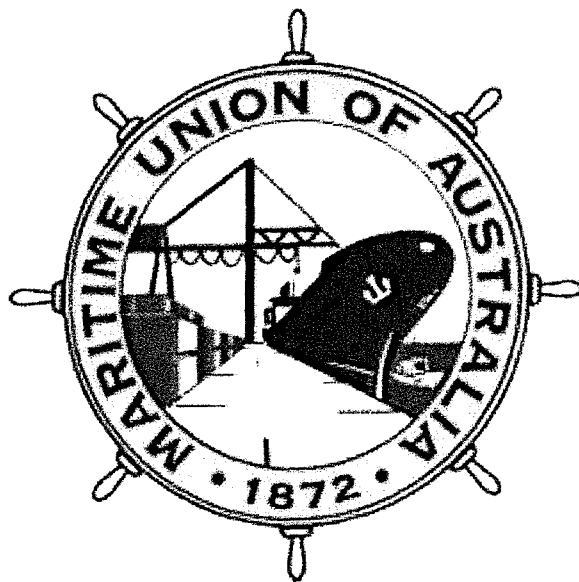
