4. The CFMEU State Branches, including the Branch, consists of the members and officers of each Divisional (or District) Branch in each State or Territory.

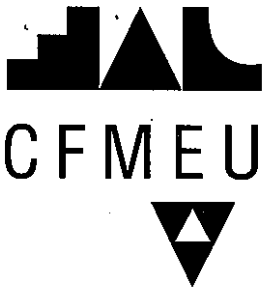

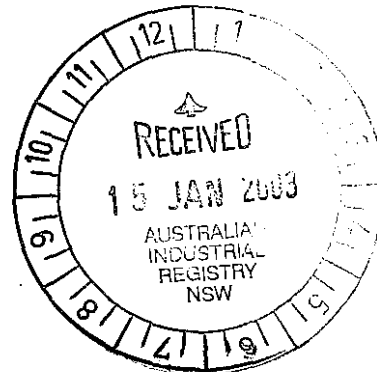
