RE: Forestry, Furnishing, Building Products and Manufacturing Division (FFPD) - Quadrennial Elections - 2012

Further to your email of 28 August 2012 in relation to our request for the conduct of quadrennial elections, and to our discussions regarding that matter this afternoon, we attach amended prescribed information addressing the issues and questions you have raised with us.

In relation to those questions we advise that:

Question 1:

Having reviewed the Rules, we now believe that your interpretation of the Rules is correct and that the Victorian District will be limited to a maximum of 3 Vice Presidents, once of which will be an affirmative action position. We have amended the prescribed information to reflect this position. The attached Schedule replaces the version of Schedule G previously filed in relation to the Victorian District.

Question 2:

Having reviewed the Rules, we now believe that your interpretation of the Rules is correct and that the Victorian District is entitled to 15 Committee of management positions, one of which will be an affirmative action position. We have amended the prescribed information to reflect this position. The attached Schedule replaces the version of Schedule G previously filed in relation to the Victorian District.

Question 3:

Having reviewed the Rules in light of your question it now appears to us that the specific terms in Rule 42(8) are intended to prevail over the general terms in Rule 30A insofar as they prescribe the numerical constitution of the PPW District Committee of Management. Rule 42(8) is inconsistent with Rule 30A in relation to the numerical makeup of the Committee and we say that it is intended to cover the field in relation to this issue. As Rule 42 does not allow for Affirmative Action positions on the PPW District Committee of Management, it is now our view that no such election is able to be conducted under the Rules at the present time.

In the circumstances, we have amended the prescribed information in relation to the PPW District by deleting the request for the conduct of elections previously sought in relation to the two Affirmative Action positions. The attached version of Schedule H replaces the version of Schedule H previously filed in relation to the PPW District. We advise that it is our intention to seek a variation to the Rules to allow for the election of affirmative action positions to the PPW District Committee of Management, in the near future.

Question 4:

Regarding the issue you have raised in relation to the provision for the election of District Officers, it is our view that as the transitional provisions set out in Rule 43 require that elections for District Offices be conducted in accordance with Rule 32 and therefore, in order to ensure that this rule is efficacious it can be implied that that Rule 32 is intended to apply with such changes as are necessary to ensure that references to a Divisional office may be read as references to District Offices. Taking this into account it is our view that Rule 32 should apply so that the method of election for the District officers is direct election and so that the electorate for each District Office is the District to which that Office relates, as was set out in the prescribed information previously filed in relation to each District.

I seek your advice in relation to the following questions about the election details lodged with FWA on 23 August 2012.

Question 1

......

On the first page entitled "Schedule G – Victorian District" the number of Vice-Presidents requested for election is indicated as "4 (including 1 Affirmative Action position)". Rule 30.A.(i) provides

A. District Management Committee:

(i)	Each District shall have a Management Committee that shall consist of a President,
Secret	ary, a Vice President, elected Organisers (if any) and no less than three Management
Comm	ittee members

Prior to the calling of nominations the Divisional Executive may determine after considering any recommendations from a District Management Committee that that District Management Committee shall also consist of any of the following further members:

a. up to two (2) further Vice-Presidents, one of which will be a designated affirmative action position;

I believe this means that the number of Vice Presidents (one of which will be a designated affirmative action position) is limited to a maximum of three (3). Do you agree with my reading of the rules here?

Question 2

On the following page of Schedule G – Victorian District, the number of Committee of Management members requested for election is indicated as "15 (including 2 Affirmative Action positions)". Rule 30.A.(i) goes on to provide

c. no more than fourteen (14) further Committee members, one of which will be a designated affirmative action position.

Nominations for the designated affirmative action positions will be called from female members only, although this does not preclude female members from holding any other District Management Committee positions.

elieve this means that the number of Committee members that can be designated as an affirmative action position is limited to a maximum of one (1). Do you agree with my reading of the rules here?

Question 3

On the page entitled "Schedule H – PPW District", the number of Committee of Management members requested for election is indicated as "2 (2 Affirmative Action positions)". My question here is the same. I think that only one of these positions can be described as an "affirmative action" position. Do you agree?

I believe that the election details as provided inadvertently reflected to some extent the former rule 33.

Question 4

My final question relates to the apparent absence of any explicit provision in the rules to define the election method and electorate for District offices. You will notice that:-

sub-rules 8(iii) and 8(iv) make clear how Conference Delegates are elected and by whom; sub-rules 9(ii) and 9(iii) make clear how the Divisional Vice Presidents and Executive Members are elected and by whom;

rule 32 makes clear how and by whom the Divisional Officers are elected; and sub-rules 42(8), (10), (11) and (18) make clear how the PPW District Officers and Sub-Branch Delegates and Committees are elected.

However, I could not find a similar rule that explicitly applied to the officers of the other Districts. Neither Rule 30 nor Rule 43 appeared to do so. Can you point to the rule on which the Division relies to identify the electorate and election method for these other Districts' offices?

My reading of the former election rule 44 is that it did appear to implicitly provide that Branch and District offices were elected through the postal ballot procedures set out in that rule, not least because of the former sub-rule 44(e) which stated:

e. The elections for each of the offices provided for in Sub Rules (b) and (c) of this Rule shall be conducted with the necessary changes in accordance with the provisions of Sub Rule (d) shall be a reference to a Divisional Office or body shall be references to the corresponding Divisional Branch, District or PPW Sub Branch Office or body for the purposes of this Rule.

However, there does not seem to have been an equivalent rule retained in the new rules certified on 15 August.

I would appreciate your advice and any comments in relation to the above. My concern is to ensure that the Election Decision will accurately describe the offices requested and encompass only those offices which are required under the rules to commence terms in January 2013.
