### **Reminder of actions required when persons elected to office**

The Australian Electoral Commission has provided the Registered Organisations Commission (the ROC) a declaration of results for the election of uncontested offices for Forestry, Furnishing, Building Products and Manufacturing Division [E2017/139]. This letter is a reminder of certain obligations imposed on organisations and on persons elected to office.

#### **A notice must be published on the organisation's website**

The organisation or branch must publish on its website a notice that a copy of the report is available from the organisation, branch or the AEC on request. The notice must be kept on the website for a period of at least 3 months (see regulation 141 of the Fair Work (Registered Organisations) Regulations 2009).

#### **Holders of office required to undertake approved training**

Section 293K of the *Fair Work (Registered Organisations) Act 2009* (the RO Act) requires each officer with financial management duties to undertake approved training that covers those duties within 6 months after the person begins to hold office. Please ensure that relevant officers undertake approved training within the required timeframe. Please also ensure that all new holders of office are advised of their obligations to make disclosures regarding remuneration, non-cash benefits and material personal interests, the details of which are provided for in the RO Act.

#### **Organisation must notify the Commission of changes**

Also, section 233(2) of the RO Act requires that an organisation must notify the Commission **within 35 days of any changes** to the holders of office in the organisation. **If there are no changes a notification is not required.** If the election has resulted in **any changes** to the holders of office, the Construction, Forestry, Mining and Energy Union - FFPD - Pulp and Paper Workers Divisional District must notify the Commission of these changes. In particular, please advise:

1. Person(s) who have ceased to hold office:
  - the name of the office vacated;
  - the date of the change of office holder; and
  - the name of the person vacating the office.
  
2. Person(s) who have commenced to hold office:
  - the name of the office now held;
  - the date of the change of office holder;
  - the name of the person now holding the office;

- the postal address of the person (generally the postal address of the organisation); and
- the occupation of the person now holding the office.

The notification must include a declaration by the Secretary (or other prescribed officer) that the information is a correct statement of the changes made. A template notification of changes, which may assist you, is attached. If any change does not apply until a date in the future, you do not need to notify until then (e.g. AGM, 1 January, 2nd Monday in March). If you have already lodged this information, please disregard this reminder.

*Arrangement for conduct of election.*

[1] On 17 May 2017 the Forestry, Furnishing, Building Products and Manufacturing Division of the Construction, Forestry, Mining and Energy Union lodged with the Registered Organisations Commission the prescribed information in relation to an election for the offices set out in Attachment A.

[2] Twenty-one of the offices remained unfilled due to insufficient nominations at the previous scheduled election,<sup>1</sup> and seven offices were deemed vacated following the election of the relevant officers-elect to other offices. Under the rules, those offices are not permitted to be held concurrently by the same persons.<sup>2</sup>

[3] I am satisfied that an election for the offices set out in Attachment A is required to be held under the rules of the organisation and, under subsection 189(3) of the *Fair Work (Registered Organisations) Act 2009*, I am making arrangements for the conduct of the election of those offices by the Australian Electoral Commission.

**RE: Forestry, Furnishing, Building Products and Manufacturing Division (FFPD) – Pulp and Paper Workers' District - Elections arising from Casual Vacancies - 2017**

In accordance with s.189(1) of the *Fair Work (Registered Organisations) Act 2009*, the Construction Forestry Mining and Energy Union (CFMEU) Forestry, Furnishing, Building Products and Manufacturing Division (FFPD), is required to lodge with the Fair Work Commission (FWC) the prescribed information in relation to an election for positions in the Division.

Accordingly we ask that the General Manager arrange for the conduct of those elections by the Australian Electoral Commission.

The Statement and Prescribed Information required by Regulation 138 of the *Fair Work (Registered Organisations) Regulations (2009)* are attached.

The need for these elections arises as result of the outcome of the election conducted in E2016/153 in the Pulp and Paper Workers' District (PPW), and the PPW sub-branches of Millicent, Maryvale, Tumut, Sydney. The result of this election was that 21 positions were either not filled or received no nominations, and six persons were elected to more than one of the following positions: Sub-Branch Senior Vice-President, Sub-Branch Junior Vice-President, Sub-Branch Committee member, Sub-Branch Secretary, or Additional Sub-Branch Delegate to District Committee of Management.

### **Casual vacancies**

As Rule 33 of the Union's rules prescribes that a casual vacancy shall occur in any office of the Division when the holder of the office ceases to hold office in accordance with the rules, and rule 32(b)(v) provides that the term of office for District Management Committee Members and PPW officers shall be 4 years commencing on 2 January, various office holders ceased to hold office on 2 January 2017. Rule 33 goes on to say that where a casual vacancy occurs and the unexpired portion of the term of office is more than 12 months or three quarters of the term of office whichever is the greater, the vacancy shall be filled by election in accordance with Rule 32.

### ***PPW District***

One affirmative action position on the PPW District Committee of Management was not filled. Accordingly there is one vacancy which is required to be filled.

### ***Tumut Sub-Branch & Sydney Sub-Branch***

No nominations were received for 14 offices in the Tumut Sub-Branch. Accordingly, there are 14 vacancies which are required to be filled. No nominations were received for six offices in the Sydney Sub-Branch. Accordingly there are six vacancies which are required to be filled.

### **Election to multiple positions**

As rules 42(19)(a) and 42(19)(b) of the Union's rules prescribe that if any person is elected to two or more of the relevant above-mentioned offices that person shall, within five days of the declaration of the result of the election, advise the Sub-Branch Secretary or Sub-Branch President which of the offices to which they have been elected they wish to hold, and will thereafter be deemed to have resigned from the other office. The rules goes on to say that the office or offices which are thereby vacated shall be filled in accordance with the provisions of Rule 32 of the Union's rules mutatis mutandis, which require that an election be held.

### ***Millicent Sub-Branch***

The following officers who were elected to both the Millicent Sub-Branch Committee of Management and one other office have advised the Sub-Branch Secretary in writing that they wish to retain the other offices and are therefore deemed to have resigned from their positions on the Sub-Branch Committee of Management.

- Brett Kelly
- Craig O'Connor

Brett Kelly was also elected to the office of Additional Delegate to District Committee of Management. Upon electing to hold the position of Sub Branch Secretary, he was therefore deemed to have resigned from the position of Additional Delegate.

Accordingly, there are three vacancies on the Millicent Sub-Branch Committee of Management, and one vacancy for the office of Additional Delegate to District Committee of Management which are required to be filled in accordance with Rule 32.

***Maryvale Sub-Branch***

The following officers who were elected to both the Maryvale Sub-Branch Committee of Management and one other office have advised the Sub-Branch Secretary in writing that they wish to retain the other offices and are therefore deemed to have resigned from their positions on the Sub-Branch Committee of management.


