Reminder of actions required when persons elected to office

The Australian Electoral Commission has provided the Registered Organisations Commission (the ROC) a declaration of results for the election of stage 1 and 2 uncontested offices for Construction and General Division [E2017/161]. This letter is a reminder of certain obligations imposed on organisations and on persons elected to office.

A notice must be published on the organisation's website

The organisation or branch must publish on its website a notice that a copy of the report is available from the organisation, branch or the AEC on request. The notice must be kept on the website for a period of at least 3 months (see regulation 141 of the Fair Work (Registered Organisations) Regulations 2009).

Holders of office required to undertake approved training

Section 293K of the *Fair Work (Registered Organisations) Act 2009* (the RO Act) requires each officer with financial management duties to undertake approved training that covers those duties within 6 months after the person begins to hold office. Please ensure that relevant officers undertake approved training within the required timeframe. Please also ensure that all new holders of office are advised of their obligations to make disclosures regarding remuneration, non-cash benefits and material personal interests, the details of which are provided for in the RO Act.

Organisation must notify the Commission of changes

Also, section 233(2) of the RO Act requires that an organisation must notify the Commission within 35 days of any changes to the holders of office in the organisation. If there are no changes a notification is not required. If the election has resulted in any changes to the holders of office, the Construction, Forestry, Mining and Energy Union-Construction and General Division must notify the Commission of these changes. In particular, please advise:

- 1. Person(s) who have ceased to hold office:
 - the name of the office vacated;
 - the date of the change of office holder; and
 - the name of the person vacating the office.
- 2. Person(s) who have commenced to hold office:
 - the name of the office now held;
 - the date of the change of office holder;
 - the name of the person now holding the office;
 - the postal address of the person (generally the postal address of the organisation); and

• the occupation of the person now holding the office.

The notification must include a declaration by the Secretary (or other prescribed officer) that the information is a correct statement of the changes made. A template notification of changes, which may assist you, is attached. If any change does not apply until a date in the future, you do not need to notify until then (e.g. AGM, 1 January, 2nd Monday in March). If you have already lodged this information, please disregard this reminder.



Prescribed Information in Relation to an Election

The following prescribed information is provided pursuant to s. 189 of the Fair Work (Registered Organisations) Act 2009 and Regulation 138 of the Fair Work (Registered Organisations) Regulations 2009:

(a) The name of each office in respect of which an election is required;

(i)	One (1)	Divisional Secretary
(ii)	Two (2)	Divisional Assistant Secretaries
(iii)	One (1)	Divisional President
(iv)	One (1)	Divisional Senior Vice-President
(v)	One (1)	Divisional Vice-President
(vi)	Three (3)	Divisional Trustees
(vii)	Two (2)	Additional Divisional Executive Members (Victoria-Tasmania)
(viii)	One (1)	Additional Divisional Executive Member (Queensland-Northern Territory)
(ix)	One (1)	Additional Divisional Executive Member (New South Wales)

(b) The reason for the election;

Expiry of the term of office of current office holders.

(c) Where more than one of the offices in respect of which an election is required has the same name and the number of such offices can, in accordance with the rules of the relevant organisation or branch, be ascertained before the prescribed day – the number of these offices;

See information provided in (a) above.

(d) Where the electorate comprises only members of a branch, section or other division of an organisation – the name of that branch, section or division;

The Divisional officers/Divisional Executive members are elected by and from Divisional Branch Delegates to the Divisional Conference of the Construction and General Division of the CFMEU.

Provided however Rule 9 1.A relevantly provides that the Additional Divisional Executive members, referred to in (a) above, shall be nominated and elected by and from bodies comprising the Divisional Conference delegates from the Victoria-Tasmania Divisional Branch (in the case of the Additional Victoria-Tasmania Divisional Branch representatives), the Queensland-Northern Territory Divisional Branch (in the case of the Additional Queensland-Northern Territory Divisional Branch representative) and the New South Wales Divisional Branch (in the case of the Additional New South Wales Divisional Branch representative), respectively.

Rule 9. 6 also provides that following the election of the Additional Divisional Executive Members, the ballot for the three (3) Divisional Trustees shall be dealt with and completed.

(e) The date and time of the commencement and expiration of the period during which nominations of candidates will be called for or may be made under the rules;

Rule 9 5. of the Construction and General Division Rules relevantly provides that nominations shall be called for by the Returning Officer on a date fixed by the Returning Officer following the fixing by Divisional Executive pursuant to sub-rule 8(xi) of a date and place for the holding of elections required under this rule and shall close fourteen days after nominations are called.

The Divisional Executive has determined that the elections shall be held on Monday 9th October, 2017 at Perth in the State of Western Australia.

(f) The voting system to be employed in the conduct of the election;

A collegiate electoral system is to be employed in the election, the relevant college being those persons elected as Divisional Branch Delegates to the Divisional Conference of the Construction and General Division of the CFMEU. See also (d) above.

Ex Officio Divisional Executive Members

We further advise that such Divisional Branch Secretaries who are not elected to any of the positions referred to in (a) herein shall also be declared elected members of the Divisional Executive although no ballot is required.

Other Matters

Further, the Returning Officer is required under the rules to call nominations to determine which of the two (2) Divisional Assistant Secretaries will be the designated Divisional Assistant Secretary and if necessary, conduct a ballot to determine the election.
