The following prescribed information is provided pursuant to Regulation 138 of the fair Work (Registered Organisations) Regulations 2009:

(a) The name of each office in respect of which an election is required;

(vii)	One (1)	Divisional Executive Member (Plasterers)
(viii)	Two (2)	Additional Divisional Executive Members (NSW)
(ix)	One (1)	Additional Divisional Executive Member (WA)

(b) The reason for the election;

Expiry of the term of office of each of the current office holders.

(c) Where more than one of the offices in respect of which an election is required has the same name and the number of such offices can, in accordance with the rules of the relevant organisation or branch, be ascertained before the prescribed day – the number of these offices;

See information provided in (a) above.

(d) Where the electorate comprises only members of a branch, section or other division of an organisation – the name of that branch, section or division;

The officers referred to herein are elected by and from Divisional Branch Delegates to Divisional Conference of the Construction and General Division of the CFMEU. One of the three Divisional Vice-Presidents shall be elected by and from such Divisional Branch Delegates to Divisional Conference as hold the office of Divisional Branch Assistant Secretary (Plasterers).

Further Rule 9 1. of the Construction and General Division rules relevantly provides that the additional Divisional Executive members, referred to in (a) above [the "Additional Divisional Executive members"], shall be nominated and elected by and from bodies comprising the Divisional Conference delegates from the NSW Divisional Branch (in the case of the additional NSW Divisional Branch representatives) and the Divisional Conference delegates from the WA Divisional Branch (in the case of the additional WA Divisional Branch representative) respectively.

(c) The date and time of the commencement and expiration of the period during which nominations of candidates will be called for or may be made under the rules;

Rule 9 5. of the Construction and General Division Rules relevantly provides that nominations shall be called for by the Returning Officer on a date fixed by the Returning Officer following the fixing by Divisional Executive pursuant to sub-rule 8(xi) of a date and place for the holding of elections required under this rule and shall close fourteen days after nominations are called.

The Divisional Executive has determined that the elections shall be held on Tuesday 13th October, 2009 at Coolangatta in the State of Queensland.

(f) The voting system to be employed in the conduct of the election;

A collegiate electoral system is to be employed in the election, the relevant college being those persons elected as Divisional Branch Delegates to the Divisional Conference of the Construction and General Division of the CFMEU. See also (d) above.

Ex Officio Divisional Executive Members

We further advise that such Divisional Branch Secretaries who are not elected to any of the positions referred to in (a)(i) to (v) herein shall also be declared elected members of the Divisional Executive although no ballot is required. Further, the rules provide that the Victorian Divisional Branch Assistant Secretary (FEDFA) shall be an additional member of the Divisional Executive. The Divisional Branch Senior Vice-President of the South Australian Divisional Branch and the Industry Divisional Branch Secretary of the Brick,

Tile, Pottery, Construction Materials and related Products Industry Divisional Branch shall, ex officio, also be members of the Divisional Executive.

Other Matters

Further, the Returning Officer is required under the rules to call nominations to determine which of the two (2) Divisional Assistant Secretaries will be the designated Divisional Assistant Secretary and if necessary, conduct a ballot to determine the election.
