

I refer to our discussion yesterday in relation to the information provided by the Division in respect of the forthcoming election and in particular, the description of the offices of Divisional Branch Assistant Secretary/ies of the South Australian Divisional Branch.

As discussed and as reflected in the information provided, the rules of the Division currently provide that there shall be two Divisional Branch Assistant Secretaries in the State of South Australia [Rule 37(vii)] and see also Rule 42(a)(vii)].

Rule 9. 1. also provides, inter alia, that:

The Divisional Branch Assistant Secretary (designated) of the South Australian Divisional Branch shall, by virtue of the holding of such office, be a member of the Divisional Executive and be a member of the National Conference and National Executive of the union.

Further, Rule 8(ii) includes the following:

The Divisional Branch Assistant Secretary of the South Australian Divisional Branch shall, by virtue of the holding of such office, be a member of the Divisional Conference.

According to our records the two immediately preceding sub-rules were inserted into the rules in Matter R 2010/100 on 23 November 2010. When they were inserted, those sub-rules rescinded and replaced two earlier sub-rules which were, respectively, in the following terms:

Further provided that the Divisional Branch President of the integrated Divisional Branch in the State of South Australia shall, until the declaration of the election in 2004 only, be, by virtue of the holding of such office, a member of the Divisional Conference. Thereafter the Divisional Branch Senior Vice-President of the integrated Divisional Branch in the State of South Australia shall, by virtue of the holding of such office, be a member of the Divisional Conference

and

Further provided that the Divisional Branch President of the integrated Divisional Branch in the State of South Australia shall, only until the declaration of the election in 2004, be a member of the Divisional Executive. Thereafter the Divisional Branch Senior Vice-President of the integrated Divisional Branch in the State of South Australia shall, by virtue of the holding of such office, be a member of the Divisional Executive and be a member of the National Conference and National Executive of the union.

The previous sub-rules made it clear that it was one and the same office-holder namely, the holder of the office of Divisional Branch President [and later, the office of Divisional Branch Senior Vice-President], who held positions on both the Divisional Executive and Divisional Conference ex officio, i.e. on the basis of the office which they occupied at the Divisional Branch level. This is consistent with our understanding outlined yesterday that it is now the Divisional Branch Assistant Secretary (designated) who also holds and will hold the office of Divisional Executive member and Divisional Conference delegate.

I also draw your attention to Rule 45(b) of the Division's rules which provides, inter alia:

...... The designated Divisional Branch Assistant Secretary will be determined by the Divisional Branch Committee of Management.

In the circumstances, and having regard to the above including the fact that the determination of the designated Assistant Secretary would appear to be a matter for the Divisional Branch Management Committee, FWA may wish to give consideration to simply describing the South Australian offices for the purposes of this election as including "Divisional Branch Assistant Secretary (2)". It may also be desirable that a notation be included to make it clear that one of these Assistant Secretaries, will, by operation of the rules and following a decision of the Divisional Branch Management Committee, also be and become a member of the Divisional Executive and a delegate to Divisional Conference.

#### STATEMENT

i, Martin O'Malley, union official of 1<sup>st</sup> floor Trades Hall 32 South Terrace, Adelaide in the State of South Australia, state as follows:

- I am the Divisional Branch Secretary of the CFMEU Construction and General Division South Australian Divisional Branch (the Branch). I have held this position since 1 August 1996.
- 2. The matters set out in this statement are recorded for the purpose of assisting Fair Work Australia consider proposed alterations to the rules of the CFMEU-Construction and General Division which were filed with FWA on 14 October 2010 and which relate to various offices and office holders of the Branch. The matters are true and correct to the best of my knowledge and belief.
- 3. Following the merger between various state registered counterparts of the former Australia Building and Construction Employees and Builders Labourers Federation (BLF) and the CFMEU in the early 1990's, two Divisional Branches were created within the Construction and General Division of CFMEU in the state of South Australia. I was the Secretary of one of these Divisional Branches which was known as the 'South Australian Construction Labourers Divisional Branch'. The second Branch was called the 'Construction Workers' Divisional Branch.'
- 4. During 1996 and by agreement, the two South Australian Divisional Branches referred to above were merged into a single Divisional Branch and rule alterations were approved to effect this merger (R20077 of 1996). I became the Secretary of the new combined Divisional Branch. The former Secretary of the Construction Workers Divisional Branch became the Divisional Branch President of the combined Divisional Branch.
- 5. Further, to ensure that both of the Divisional Branches continued to be represented on Divisional and National Governing bodies it was agreed that a senior officer of the former Construction Workers' Divisional Branch would sit on such bodies. Consequently Rules 8 and 9 of the Construction and General Division Rules were

amended such that the Divisional Branch President of the new combined Divisional Branch would sit on the respective governing bodies referred to in those rules.

- 6. Later, in 2004, the rules were further amended (R2004/329) to provide that the person occupying the office of Senior Vice-President of the Divisional Branch was to be a member of the Divisional Comference and Divisional Executive. As part of those changes the office of Divisional Branch. President became an honorary position within the Divisional Branch.
- 7. During the 2008 Divisional Branch elections within the Construction and General Division of the CFMEU, Mr. Justin Feehan [Feehan] was elected as Divisional Branch Senior Vice-President. Feehan's term of office commenced at the beginning of 2009.
- 8. At some point in late August 2009 Feehan notified the Branch of his intention to resign from his position within the Divisional Branch. The Divisional Branch Management Committee was advised of Mr. Feehan's intention to resign.
- 9. After some discussion with Feehan it was agreed that Feehan would be given the option of returning to his previous position if he wished to do so within approximately six months from the date of his resignation. This proposal was agreed to by the Management Committee. Mr. Feehan was advised of the Branch's decision to leave the position vacant for a period of six months so that he might be able to fill it if that was his wish and the wish of the Management Committee during that period.
- 10. Mr. Feehan last worked for the Divisional Branch on 28 August 2009 and was paid up to that date and paid out all accrued entitlements. He did not express any wish to the Branch to return to his previous position at the end of or during the six month period. I understand that he is presently working full-time in a position as Employee Coordinator with Adelaide Aqua at the Adelaide desalination plant construction site and has been in that position since he last worked for the Branch.
- 11. During the second quarter of 2010 the Divisional Branch Management Committee discussed the possible re-organisation and restructure of the Divisional Branch including the implications for the Branch of Feehan's resignation. The Divisional Branch Management Committee came to the view that rather than fill the casual vacancy created by Feehan's resignation or continue to leave the office vacant that they would raise the issue at the Divisional Executive level and request that the office be abolished. This decision was taken in part because of the view by the Divisional Branch Management Committee that it was unnecessary and uneconomic to fill the position, which was a full-time paid position, with another person.
- 12. The Divisional Branch Management Committee however also came to the view that the Divisional Branch's representation on Divisional and National bodies should not be diminished as a result of these changes. I was asked by the Divisional Branch Management Committee to pursue formal rules changes that would achieve this objective by ensuring that a senior Divisional Branch officer would take up those.

positions previously occupied by Feehan. After some discussion with the National Office of the Construction Division and at the Divisional Executive it was determined to proceed by abolishing the Divisional Branch Senior Vice-President position and substituting a Divisional Branch Assistant Secretary on these Divisional governing bodies:

13. Since the Divisional Executive voted to approve the present rule changes! have spoken with Feehan and advised him of the Executive's decision. He also understands that the proposed changes are now being considered for approval by Fair Work Australia. Feehan did not and has not raised any objection with me or the South Australian Divisional Branch in relation to these proposed changes. In the course of my discussion with Feehan he agreed to provide a written letter evidencing his resignation a copy of which is annexed to this statement.

### Re: Scheduled Elections - Construction and General Divisional Branches (E2012/308)

I refer to your letter dated 29 June 2012 enclosing prescribed information in respect of the above election, which was lodged under subsection 189(1) of the Fair Work (Registered Organisations) Act 2009 and received by Fair Work Australia on that day.

I have identified what I believe to be two errors in the list of offices for the New South Wales Divisional Branch and an error in the list of positions requested under s187 for the South Australia Divisional Branch. These are:

#### Number of Delegates (NSW Branch)

(a) The number of "Divisional Branch Delegate to Divisional Conference" is listed as "(8)". If this is added to the "Divisional Branch Secretary / Divisional Branch Delegate to Divisional Conference" (who is a Delegate to Divisional Conference ex officio, by virtue of sub-rule 8(ii)), this brings the total of Branch Delegates to Divisional Conference to 9. By my reckoning, based on the average membership figure of 13,380, as provided by your office, and in accordance with sub-rule 8(iii), the total should be no more than seven (7) including the Divisional Branch Secretary. This would mean that the number for "Divisional Branch Delegate to Divisional Conference" should be indicated as six (6). This number is only increased if a fulltime Divisional Officer nominates in accordance with sub-rule 8(viii). I was advised by Mr Ashley Borg, of your office, that Mr Lindsay Fraser, a Divisional Assistant Secretary from the New South Wales Branch, will nominate in accordance with this sub-rule. Accordingly, I calculate that the number for "Divisional Branch Delegate to Divisional Conference" should be indicated as seven (7).

I seek your comment on whether you agree with my calculation. If you do, the Decision should reflect this calculation and show the number of "Divisional Branch Delegate to Divisional Conference" as "(7)".

### Description of Zones and numbers (NSW Branch)

(b) The Zones are listed as "Sydney Zone (27)" - "Newcastle Zone (3)" - "Wollongong Zone (3)" and "Country Zone (3)". The rule alterations certified on 15 December 2011 in matter R2011/248 included a new sub-rule 42(i)(d) which changed the names of the Zones and the number of Councillors for the first of these Zones. The prescribed information should therefore have listed the Zones as "Cumberland Zone (22)" - "Northumberland Zone (3)" - "Camden Zone (3)" -"Country Zone (3)" and the total number for "Divisional Branch Council Members" should have been "(31)".

I seek your comment on whether you agree with my reading of the relevant rule. If you do, the Decision should reflect these descriptions and the number (22) for the Cumberland Zone.

### Positions of Divisional Branch Organiser (SA Branch)

I also query the number of Divisional Branch Organiser "positions" for the South Australia Divisional Branch, which is indicated as "(2)" and which is in addition to the two (2) "Divisional Branch Organiser/Divisional Branch Management Committee Member" listed elsewhere in the prescribed information.

Offices of Divisional Branch Organiser for the South Australian Divisional Branch appear to be established by sub-rules 37(vi) and 42(a)(vi). Provision is made for positions of Organiser in respect of the other Branches in the sub-rules pertaining to them, but in sub-rule 37(vi) there does not appear to be any provision made for additional Divisional Branch Organisers in respect of the South Australia Divisional Branch. The sub-rule simply provides that Branch offices will include members of the Branch Committee of Management, and sub-rule 42(a)(vi) includes two Organisers as members of the Branch Committee of Management. Moreover, no mention was made of additional Organiser positions in respect of the South Australia Divisional Branch in the previous Election Decision granted in matter E2008/204.

I believe the reference to two (2) Divisional Branch Organiser positions under the heading "g. South Australia Divisional Branch" is an error and should have been omitted. I seek your comment on whether you agree with my reading of the rules. If you do, the Decision should omit reference to these two positions.

If you agree that I have correctly identified errors, then, in order to avoid any later confusion over the document record, I suggest that the Division lodge an amended prescribed information in relation to the offices of the New South Wales Divisional Branch, and in relation to the position requested under s187. The Division should also make an amended request under s187 to the AEC.

### **Divisional Officers nominations**

I note that the number of "Divisional Branch Delegate to Divisional Conference" listed for the new Victoria-Tasmania Divisional Branch is indicated as "(15)". The average membership figure of 27,459 provided for Victoria and Tasmania entitles the Branch to a total of fourteen (14) including the Divisional Branch Secretary who is a Delegate ex officio). This would normally mean that the number that should have been indicated was (13).

However I was advised by Mr Ashley Borg, of your office, that you and Mr Frank O'Grady, DivIsional Secretary and Divisional Assistant Secretary respectively from the Victoria-Tasmania Branch, will be nominating in accordance with sub-rule 8(viii). I understand therefore that the figure of "(15)" includes two (2) Divisional Officer Delegates in addition to the thirteen (13) that would otherwise have been indicated.

I seek your confirmation that my understanding is correct, and your advice whether any other full-time Divisional or National Officers intend nominating as Delegate in accordance with sub-rule 8(viii).






