Arrangements for the conduct of an election (E2013/233)

I refer to the prescribed information dated 25 July 2013 which was lodged with the Fair Work Commission on 25 July 2013 for a scheduled election of the Divisional Executive of the Construction and General Division (the Division) of the Construction, Forestry, Mining and Energy Union.

New rule 9.1.A of the Divisional rulebook provides that the number of Additional Divisional Executive Members to be elected in any Divisional Branch is to be calculated on the basis of the number of financial members within that Branch as at 31 March in the year of the election. The Fair Work Commission has not been provided with those numbers.

To enable the Fair Work Commission to confirm the correct number of Additional Divisional Executive Members as requested in the prescribed information, could you provide me with the number of financial members of each Divisional Branch as at 31 March 2013.

I note that this election follows a rule alteration in matter R2013/296, in which new rule 9.1.A was inserted into the Divisional rulebook. To avoid future confusion and ambiguity, I recommend the Division make further alterations to remove existing rule 9.1, and to make other alterations in rule 9 generally, where references to superseded officers are stated.

(e) The date and time of the commencement and expiration of the period during which nominations of candidates will be called for or may be made under the rules;

Rule 9 5. of the Construction and General Division Rules relevantly provides that nominations shall be called for by the Returning Officer on a date fixed by the Returning Officer following the fixing by Divisional Executive pursuant to sub-rule 8(xi) of a date and place for the holding of elections required under this rule and shall close fourteen days after nominations are called.

The Divisional Executive has determined that the elections shall be held on Monday 14th October, 2013 at Cairns in the State of Queensland.

(f) The voting system to be employed in the conduct of the election;

A collegiate electoral system is to be employed in the election, the relevant college being those persons elected as Divisional Branch Delegates to the Divisional Conference of the Construction and General Division of the CFMEU. See also (d) above.

Ex Officio Divisional Executive Members

We further advise that such Divisional Branch Secretaries who are not elected to any of the positions referred to in (a) herein shall also be declared elected members of the Divisional Executive although no ballot is required.

Other Matters

Further, the Returning Officer is required under the rules to call nominations to determine which of the two (2) Divisional Assistant Secretaries will be the designated Divisional Assistant Secretary and if necessary, conduct a ballot to determine the election.
