Other Matters

- Rules regarding the timetable of the election were set aside as the AEC held concerns that the coronavirus pandemic may impact on the ability for stakeholders to fully participate in the election. A timetable for the conduct of the ballot which varied from the rules was set when the AEC was satisfied that stakeholders would be able to fully participate.
- The original timetable for the ballot for the office of Builders Labourers Divisional Branch Council Member Metropolitan Zone in the Victoria Tasmania Divisional Branch was delayed as the assessment of eligibility of nominees was not able to be completed within the original timelines. One contributor to this delay was that electorates for Divisional Branch Council Members were not expressly identified in the election notice. To remedy this, it is recommended that future Prescribed Information lodged by the CFMMEU include the breakdown of electorates.

Arrangement for conduct of election.

[1] On 24 August 2020, following the lodgement of prescribed information on 30 June and 31 July 2020, I issued a decision arranging for an election for this registered organisation.

[2] On 11 November 2020, the organisation notified the Commission that it had identified an error in the prescribed information that it lodged on 30 June 2020 – specifically, in relation to an office in one of the Divisional Branches.

Arrangement for conduct of election.

[1] On 30 June, 31 July and 21 August 2020 the Construction and General Division of the Construction, Forestry, Maritime, Mining and Energy Union (the Division) lodged with the Registered Organisations Commission (the ROC) prescribed information and supplementary information in relation to an election for the offices and non-office positions set out in Attachment A.

2. Reason for the Election:

An election is required because of the expiry of the current term of office of the existing officers.

3. Number of Offices with the Same Name:

The number of such offices is set out at 1 above with the number appearing in brackets.

We note that in the case of Victoria-Tasmania Divisional Branch Council Zone delegates, the number of such delegates is determined in accordance with a formula set out in rule 40(2)(v)(b) which in turn makes reference to the number of financial members as at 30 July preceding the calling of nominations. We are therefore unable to ascertain this figure at this point and will provide supplementary information on this point on or after 30 July 2020.

4. Electorate

Members of each of the Divisional Branches referred to in 1 above vote for representatives of their Divisional Branches in accordance with the rules.

The office of Divisional Branch Delegate to Divisional Conference (Northern Territory) is elected by and from members residing or employed in the Northern Territory in accordance with rule 8(viA).

The offices of Sub-Branch Secretary, Sub-Branch President and Sub-Branch Management Committee members of the Victoria-Tasmania Divisional Branch are elected by and from members residing or employed in the State of Tasmania in accordance with rule 42B(ii).

5. Nomination Period

The rules provide that nominations will open on or before Monday, 31 August 2020 and close at 4.00pm Friday, 18 September 2020.

6. Closure of Voting Roll

The rules provide that the roll of voters shall be deemed to have closed 8 days before the date on which nominations open i.e. 8 days before 31 August 2020.

7. Voting System

A direct voting system is to be employed in the conduct of the elections for the position listed at point 1, with the exception of the offices of Divisional Branch Vice-President in the Queensland Northern Divisional Branch, which will be by a collegiate electoral system in accordance with rule 40(2)(ii)(J).

The information herein is provided under subsection 189(1) of the *Fair Work (Registered Organisations) Act 2009 [FW(RO) Act]*.

Rule 8 – Construction and General Division Rules

We draw your attention to rule 8(viii) which relevantly provides that certain officers may nominate in Divisional Branch elections provided that a Divisional Branch Secretary is notified in writing prior to the date of calling for nominations. The information above relating to Divisional Branch delegates to Divisional Conference takes this provision into account. The number of such delegates is specified on the basis that each of the Divisional Secretary, Divisional Assistant Secretaries (2) and Divisional President have or will have, by the time of the calling of nominations, notified the Divisional Branch Secretary of the Divisional Branch from which they derive, of their intention to nominate for the office of Divisional Branch delegate to Divisional Conference.

Other Positions

In accordance with s 187 of the *FW(RO) Act* we hereby request that the AEC conduct an election for the following positions within the specified Divisional Branches at the same time as the election for the above offices:-
