Arrangement for conduct of election.

[1] On 17 September and 28 October 2019, the Manufacturing Division of the Construction, Forestry, Maritime, Mining and Energy Union lodged with the Registered Organisations Commission prescribed information and further information for an election to fill a casual vacancy for the remainder of the term and to also fill insufficient nominations received in a previous election (E2017/266), for the following offices:

[2] I am satisfied that an election for the abovenamed offices is required to be held under the rules of the organisation and, under subsection 189(3) of the *Fair Work (Registered Organisations) Act 2009*, I am making arrangements for the conduct of the election by the Australian Electoral Commission.

Prescribed information for E2019/171

I can confirm the information in the prescribed information is correct. Casual vacancy elections are requested for the following positions in the Manufacturing Division GGT District:

- Committee of Management Member (position 3);
- Committee of Management Member (affirmative action position);

In the letter accompanying the prescribed information sent 16 September 2019, the letter states "The need for this election arises as a result of the resignations of Gillian Kennedy (Finnigan) and Predrag Podobnik from the Committee of Management in the Greater Green Triangle District (GGT). Both resignations have previously been notified to ROC."

Predrag Podobnik was elected as a District Committee of Management Member by result of election E2016/153. He resigned on 07/02/2019 and his resignation letter is attached to this email. Predrag's resignation was notified to the ROC on 18/02/2019. We are requesting an election for this position.

The letter incorrectly suggests the second position was previously held by Gillian Kennedy. The position held by Gillian Kennedy (Finnigan) was "District Vice President (*affirmative action*)". Gillian was elected to this position by result of election E2016/153. Gillian resigned from this position on 07/02/2019 and the vacancy was notified to the ROC on 18/02/2019. This position is different to the "Committee of Management Member (*affirmative action position*)" we seek election for. The prescribed information does not request an election for "District Vice President (*affirmative action*)".


The second position we are requesting an election for as notified in the prescribed information is "Committee of Management Member (*affirmative action position*)". During election E2016/153 no nominations were received for this position. A further casual vacancy election E2017/266 was conducted to fill this vacancy. Again no nominations were received for this position. We are requesting an election for the position of "Committee of Management Member (*affirmative action position*)" again in accordance with the prescribed information.

As a consequence of Gillian resigning from the more senior position of District Vice President, the GGT District has decided to see if there is sufficient interest for the Committee of Management Member position (*affirmative action*) before requesting an election for the more senior District Vice President (*affirmative action*) position.

As per our phone conversation on 24/10/19 we are under the belief there is no legal obligation

for us to provide resignation letters, however on this occasion we are willing to provide resignation letters in good faith to assist you with this matter.
