

I, Grahame Kelly, being the General Secretary of the Construction, Forestry, Maritime, Mining and Energy Union, Mining and Energy Division make the following statement:

1. I am authorised to sign this statement containing prescribed information for the Construction, Forestry, Maritime, Mining and Energy Union, Mining and Energy Division.
2. The following information is lodged under subsection 189(1) of the *Fair Work (Registered Organisations) Act 2009* (the RO Act).
3. The elections that are required are set out in the table in Annexure A and Annexure B.
4. I have directed that a copy of the request under section 187 for the AEC to conduct an election for the non-office positions referred to in Annexure A be provided to the Registered Organisations Commission at the same time as this notice.
5. A notice of alteration of rules was lodged by the Construction, Forestry, Maritime, Mining and Energy Union, Mining and Energy Division on 20 December 2019. If the rule alterations are approved a number of them may impact on rules relevant to elections with respect to the Queensland District Branch.
6. This statement is lodged at least 2 months before nominations open for the election(s) in Annexure A and Annexure B.
7. The number of Central Councillors to be elected is calculated using the following formula in Rule 8(i)(c)(1) of the Divisional Rules:

“Each District Branch shall be entitled to one (1) representative for any number of members up to two thousand (2000) and that representative shall be the District Branch President, or where the District Branch President is not a full time District Branch Official, the next most senior officer who is a full-time District Branch Official. If the District Branch has no full-time official, the most senior officer. Where the membership of a District Branch exceeds two thousand (2000), it shall be entitled to a further representative for each additional two thousand (2000) members or part thereof. Except as provided for in sub-rule 8(i)(e), the number of representatives required shall be calculated by the General Secretary by reference to the membership records maintained by the Division pursuant to the *Fair Work (Registered Organisations) Act 2009* as at the end of the financial year immediately preceding the relevant election.”

8. The membership records disclose that the relevant number of members at the end of the financial year preceding the relevant election (31 December 2019) for calculating the formula is 6535 members in the Queensland District Branch and 924 members in the Victorian District Branch.
