Conduct of Collegiate Election

I write to advise that it is necessary for collegiate elections to be conducted for the above organisation consistent with the requirements of Sub-Rule 11, Rule 72 – Special Rule – No. 7 Branch – Pulp & Paper Workers' Branch of the registered rules of The Forestry, Furnishing, Building Products and Manufacturing Division and Forestry Divisional Branches of the Construction, Forestry, Mining and Energy Union.

Sub-Rule 11 requires that elections be conducted for the following positions:




